# ACTION REQUESTED

1. Please mark your calendars for the **February 21<sup>st</sup> Council Strategic Planning Work Session from 9:00 a.m. to 4:00 p.m.**, at the Center for Urban Waters.

# **TOPICS OF INTEREST**

2. In September 2010, the City Council approved Resolution No. 38107, which authorized a no interest loan of \$20 million for the **Murray Morgan Bridge rehabilitation**. Attached for your information, I am providing a memorandum with background information related to Local Agency Agreement, Amendment No. 2, which allows the City to accelerate the repayment of the loan and reduce the debt to \$10 million, provided the City pays the loan off within three years (2014-2016).

# STUDY SESSION/WORK SESSION

 The City Council Study Session of Tuesday, February 25, 2014, will be held in Room 16 of the Tacoma Municipal Building North, at Noon. Discussion items will be: (1) Environmental Services – Strategic Plan 2013-2018; (2) Other Items of Interest; (3) Agenda Review; (4) Closed Session; and, (5) Executive Session – Pending and Potential Litigation.

At Tuesday's Study Session, Environmental Services Department staff will share the Environmental Services Strategic Plan for 2013-2018. This Strategic Plan emphasizes the department's vision, mission, and values, as well as the goals and objectives, while addressing the increasingly complex environmental issues that our City encounters. Moreover, the plan is designed for alignment with the strategic direction of the City Council and the goals of the City Manager.

4. The updated **Tentative City Council Forecast** and **Consolidated Standing Committee Calendars** are attached for your information.

# **COUNCIL REQUESTS/INQUIRIES**

5. Recently the City Council and City Manager's Office have received numerous complaints about The News Tribune's (TNT) extra delivery placed in orange bags for non-subscribers. I met with TNT Publisher David Zeeck today to discuss these concerns. I am providing the attached memorandum, which highlights our conversation, as well as the TNT's Implementation Strategy which Mr. Zeeck shared with me today.

6. At the last Study Session, during the **Smelter Plume Project Cleanup Program** update presentation, Council Member Mello requested data on the costs of the eight cleanups completed through the program. Washington State Department of Ecology (WSDOE) Cleanup Manager, Amy Hargrove reports that the total cost of the first eight yard cleanups was \$326,912, with a cost of \$40,864 per yard.

WSDOE's \$50,000 per yard estimate was based on the Everett Smelter yard cleanups and other similar projects; however, a couple of the yards in Tacoma were smaller than average city lots. The cleanup activities include:

- Fencing and preparing the yard for cleanup.
- Soil excavation.
- Soil transportation and disposal.
- Replacement soil.
- Replacement sod, plants, and other landscaping material.

In addition, Council Member Ibsen asked who residents should contact for advice on cleaning up their own soil. The contact is WSDOE Technical Assistance Coordinator Elizabeth Weldin, <u>Elizabeth.Weldin@ecy.wa.gov</u>, or 360-407-7094.

SUBJECT: Murray Morgan Bridge Loan Repayment

DATE: February 20, 2014

This is to advise you of an opportunity that the City agreed to for reducing its debt to the Washington State Department of Transportation (WSDOT) for the Murray Morgan Bridge rehabilitation. The loan from WSDOT was for \$20 million, which would have been budgeted and paid for over the next five years (2015-2019). However, WSDOT approved the attached Local Agency Agreement, Amendment No. 2, which allows the City to accelerate the repayment of the loan and reduce the debt to \$10 million, provided the City pays the loan off within three years (2014-2016).

Since the amendment to the loan agreement is less than the original agreement that was approved by Council through Resolution No. 38107, the amendment will be done administratively by accessing reserve funding for the 2014 payment since that payment was not budgeted in this biennium. The payment in 2015 and 2016 will be \$3 million each year, which is a reduction from the original agreement of \$4 million each year and a savings of \$2 million for the next biennium, with a total saving of \$10 million over the next five years.

# Amendment No. 2 Murray Morgan Bridge Rehabilitation

This Amendment No. 2 is made and entered into between the STATE OF WASHINGTON, Department of Transportation, hereinafter the "State," and the City of Tacoma, 747 Market Street Room 408, Tacoma, WA 98402, hereinafter the "Agency."

WHEREAS, the Parties hereto entered into original Local Agency Agreement LA 7269 on the 23rd day of September, 2010, providing federal funding including a STP loan for the rehabilitation of the Murray Morgan bridge, and

WHEREAS, the Parties hereto executed Amendment No. 1 to the original Local Agency Agreement LA 7269 on the 23rd day of August, 2013, and

WHEREAS, the Agency has agreed to an accelerated repayment plan if the State provides additional federal funds,

NOW, THEREFORE, pursuant to the above recitals that are incorporated herein as if fully set forth below, and in consideration of the terms, conditions, covenants, and performances contained herein,

IT IS MUTUALLY AGREED AS FOLLOWS:

A. The Additional Provisions of Local Agency Agreement LA 7269 as amended by Amendment No. 1 are deleted and replaced with the following:

- Pursuant to RCW 39.69.020 the State loaned the Agency the sum of Twenty Million (\$20,000,000.00) Dollars, shown as "line m. Other STP Loan" on page 1 of this Agreement. The State will provide Ten Million (\$10,000,000.00) Dollars in federal funding to reduce the "line m. Other STP Loan" to Ten Million (\$10,000,000.00) Dollars.
- 2. The Agency agrees to repay the sum of Ten Million (\$10,000,000.00) Dollars to the State before April 1, 2016. Acceptable forms of payment include: check, de-obligation of funds obligated by this Agreement or other form of payment found acceptable by the State.
- 3. The State and Agency agree to the following repayment schedule:

Four Million (\$4,000,000.00) Dollars before August 1, 2014, and Three Million (\$3,000,000.00) Dollars before April 1, 2015, and Three Million (\$3,000,000.00) Dollars by April 1, 2016, for a total of Ten Million (\$10,000,000.00) Dollars.

4. The State and Agency agree that repayment is not to be considered a general obligation of the Agency but instead is an obligation payable from the identified revenues set aside for the repayment of the loan.

- 5. The Agency agrees that if it fails to make payment within the time identified in the repayment plan, the Agency will pay the STATE interest of 1% per month on portions of the loan used, retroactively beginning upon its use.
- 6. The Agency agrees that if the full sum of Ten Million (\$10,000,000.00) Dollars, plus any interest due, is not returned to the State before April 1, 2016, the State shall effect reimbursement of the total sum due from the regular monthly fuel tax allotments to the Agency from the Motor Vehicle Fund and no additional Federal project funding will be approved until full payment is received unless otherwise directed by the Director of Highways and Local Programs.
- 7. If payments have been made since the last supplement to this Agreement, the Agency agrees to supplement this Agreement at least yearly to de-obligate portions of the loan that have been repaid.
- B. All other terms of Local Agency Agreement LA 7269 and Amendment No. 1 remain in effect.

#### Summary

The City has been in discussions with the Washington State Department of Transportation (WSDOT) to reduce the \$20 million loan for the Murray Morgan Bridge rehabilitation to \$10 million if the City can accelerate the repayment of the loan (pay within the next three years). Public Works, Finance and Budget have been working on various scenarios which would allow the City to take advantage of WSDOT's offer to reduce the \$20 million loan to \$10 million. One scenario that was discussed with WSDOT, and WSDOT has shown an interest in pursuing, is a 2014-2016 repayment plan. The draft amendment to the Local Agency Agreement reflects this scenario. Staff recommends this scenario and approval of the draft amendment to the Local Agency Agreement.

#### Background

In 2009, the City began negotiations with WSDOT to transfer the Murray Morgan Bridge from the State back to the City. The Turnback Agreement was approved by Resolution No. 37941 in December 2009 and was finalized with the State in January 2010. The agreement provided \$26,277,000 in Federal funds and \$11,150,292 in State funds, for a total of \$37,427,292, toward the rehabilitation of the bridge. Because the funding provided by the Turnback Agreement was less than the estimated cost of \$65 million, the City began planning a phased approach to the rehabilitation of the bridge. In August 2010, WSDOT offered the City a \$20 million dollar no interest loan payable in 10 years to be used for the bridge rehabilitation. The City accepted the loan offer (through Resolution No. 38107) which allowed the City to complete most of the rehabilitation of the bridge. The WSDOT loan required the City to submit a repayment plan by September 2015 and complete repayment of the loan by September 2020.

In 2013, the legislature passed a Transportation Bill, ESSB 5024, that allowed a longer repayment period for the loan (up to 25 years), and specified that the loan funds were not to be considered a general obligation of the City but an obligation payable from the revenues to be identified in the repayment plan. In July 2013, WSDOT proposed reducing the \$20 million loan repayment amount to \$10 million if the City could repay the loan sooner, preferably within three years.

Public Works, Finance, and Budget evaluated WSDOT's proposal to reduce the loan and agree that it is worthwhile to pursue taking advantage of WSDOT's offer. Last month, staff discussed a repayment plan with WSDOT that would have the City pay \$4 million in July 2014, and \$3 million each in 2015 and 2016. For 2014, we would recommend using surplus General Fund dollars to make the \$4 million payment. For the 2015 and 2016 payments, we would recommend that \$6 million (\$3 million in each year) be built into the 2015-2016 biennial budget. A comparison between the reduced loan repayment using the above schedule and repayment of the \$20 million loan pursuant to the original Local Agency Agreement is shown below. WSDOT likes the City's proposal and sent a draft amendment to the Local Agency Agreement for the project (attached) for review and approval.

#### **Recommendation**

Staff recommends accepting WSDOT's offer to reduce the \$20 million loan repayment to \$10 million by approving the draft amendment to the Local Agency Agreement to repay the loan in three years. This will reduce the loan amount by 50%. According to the Agreement, \$4 million will be due by August 1, 2014, \$3 million will be due by April 1, 2015, and \$3 million will be due by April 1, 2016.

SUBJECT: The News Tribune Non-Subscriber Advertising Bags

DATE: February 20, 2014

As you are aware, the City has received numerous complaints about The News Tribune's (TNT) extra delivery placed in orange bags for non-subscribers. Citizens have requested that the City take action against the TNT for what they considered littering. Citizens have also requested that the City take action on our current Codes, or change our Codes so that the deliveries would be code violations.

Earlier today I met with TNT Publisher David Zeeck, and we had a very productive conversation about this issue and how the City and the TNT could work together to address the issue for both the residents and the TNT's advertising customers. Here are a few of the highlights of the TNT's strategy to address many of the concerns raised by residents:

- Continue the direct deliveries where it is working well and work with the Post Office to move a portion of these products back into direct mail.
- Stopping direct delivery to some neighborhoods with wide grassy strips between the street and public sidewalk, and neighborhoods that have hilly terrains with homes a few feet above street grade.
- Converting the TNT's non-subscriber product (both direct delivery and direct mail) to a weekly newspaper model, which would include news content in addition to the advertising within the next several weeks.
- Monitor the quality of the direct deliveries to ensure the carriers do not throw additional papers if the previously delivered papers are still visible, and by offering incentives for carriers with "clean" routes (picking up unretrieved papers in gutters and near storm drains).
- Offer an opt-out form on the TNT website so vacant homes can be reported and residents can request the deliveries to stop.

The above-mentioned changes that the TNT has committed to making, clearly demonstrates their willingness to work with the City and residents to address the many concerns that have been expressed. The City will continue to work with the TNT and observe whether or not the proposed changes have the desired impacts. For additional information, please see the attached Implementation Strategy which Mr. Zeeck provided during our meeting today.

# We're moving some delivery back to direct mail

- We've decided direct delivery doesn't make sense in some neighborhoods, especially where houses are close together and where property boundaries aren't clearly divided by driveways, for example. We're moving those neighborhoods back into direct mail.
- We are working to stop direct delivery to neighborhoods with especially wide grassy strips between the street and sidewalk. Delivery will go back to direct mail.
- We are working to stop direct delivery to neighborhoods with hilly terrain where homes are more than a few feet above street grade. That delivery will go back to direct mail.

# We're converting the product to a weekly paper

• Both direct delivery or direct mail products are being converted into a weekly newspaper. That weekly paper will include news content and more retail and classified advertising, in addition to inserts. That's more attractive for readers and provides another way to promote community events and share community news.

# **Improving delivery**

- We asked our delivery vendor to increase the random checks supervisors make on every route each week. They also continuously train their carriers on the GPS technology that helps carriers deliver -- and skip -- the right houses.
- Delivery will be to driveways where possible. That makes it more obvious who is intended to receive the product. That also makes it easier the next week for a carrier to spot an unretrieved paper and not deliver a second one.
- We're asking our distribution partner to constantly remind carriers not to throw a new paper if the last week's paper is still there.
- Our distribution partner instituted a carrier incentive system that puts a greater emphasis on "clean" routes. The system also puts special emphasis on keeping unretrieved papers away from storm drains.

# Making opt-out easier to find

- We set up a an opt-out form on the TNT website. It can be found at <u>www.thenewstribune.com/extraoptout</u> Residents can also use that form to report papers delivered to vacant homes, so we can check it out and stop them if needed.
- For some people who called and emailed us, it truly WAS about the bags being orange. But we also hope the clear bags allow people to find the opt-out message at a glance. More true opt-outs save us time, money, newsprint and plastic.
