SUMMARY:

A resolution authorizing the acceptance of seven grants in the total amount of \$13,010,976, to fund various Public Works projects including roadways, bridges, trails, bikeways and transportation planning.

STRATEGIC POLICY PRIORITY:

 Plan for and improve public infrastructure that meets the transportation needs of all Tacoma residents and visitors.

Acceptance of these grants will provide funding for improvement of motorized, pedestrian and bicycle facilities supporting the City's strategic policy priority to plan for and improve public infrastructure that meets the transportation needs of all Tacoma residents and visitors.

BACKGROUND:

The City has aggressively applied for grants for numerous infrastructure projects. In the past two months, Public Works projects have been selected to receive approximately \$13,010,976 in grant funds. Seven grants have been received for the following projects:

ISSUE:

Acceptance of grant funds requires matching funds from the City. Funding for grant match has been included in the City's 2015/2016 proposed biennial budget.

ALTERNATIVES:

The alternative is to not accept these grants. If the grants are not accepted, the City would pay \$13,010,976 to perform the project work. Acceptance of the grants will leverage \$2,022,194 in City match funds to provide \$15,033,170 for infrastructure improvements.

RECOMMENDATION:

The Public Works Department recommends acceptance of seven grants in the amount of \$13,010,976, to fund various Public Works projects which will leverage City funds and provide for improvement of City infrastructure including roadways, bridges, trails, bikeways and transportation planning.
