Opioid Settlement Update

[Jacques Colon, Chief Strategy Officer, Office of Strategy]

At approximately 4:33 p.m., Jacques Colon, Chief Strategy Officer, Office of Strategy, presented on the Opioid Settlement, including an agenda; opioid settlement update; opioid abatement council; Tacoma-Pierce County Opioid Task Force; Pierce County opioid strategy; spending options for jurisdictions; and settlement spending, noting no expiration date.

Discussion ensued regarding allowable uses, noting re-entry services for incarcerated individuals, funds directed to law enforcement usage, prioritizing supportive services, funds for treatment, and jurisdiction involvement; budget cycle for this biennium; juveniles receiving assistance; therapeutic court; and the Crystal Judson Family Justice Center.

Council Member Walker arrived here, at 5:03 p.m.

Discussion continued regarding funds for detox beds; Medicaid providing assistance; and other resources available.
