Briefing Items

4. [24-0262](#) Travel and Sports Tacoma Update
[Dean Burke, President and CEO, Travel Tacoma]

At approximately 10:12 a.m., Dean Burke, President and CEO, Travel Tacoma, presented an update, noting they are in the process of changing their name from Travel Tacoma to Tacoma-Pierce County Tourism Authority; background, noting role as a destination marketing organization, and pillars of business development; and the lodging ecosystem, noting rooms, how percentage is measured based off resident counts, the Pierce County hotel ecosystem, and hotel occupancy and revenue data. Burke continued with review of visitor economy, including travel and tourism performance, noting comparisons with other parts of the state; the largest and fastest growing sub-sectors in Pierce County; taxable sales in Pierce County and Tacoma; opportunities in downtown Tacoma, noting volume of visitors, opportunities for visitors within 50-249 miles and over 250 miles away; 2023 results; core segments; challenges to our success; and other market interruptions.

Discussion ensued regarding perception, safety during events, surveys, security, additional contracts, business name change, short term rentals, funding, County and City issues, volume of tourism, top three reasons why people stay or visit Tacoma, and ways to represent the City.
