Briefing Items

2. <u>16-0861</u>

Transit Oriented Development Update (Pat Beard, Project Manager, Community and Economic Development)

At approximately 10:09 a.m., Pat Beard, Community and Economic Development, provided an overview of the transit oriented development (TOD) construction sites located along the Tacoma Link extension and introduced Eli Moreno, Premier Residential, and Kim Nakamura,

Stadium Apartments LLC. Ms. Beard discussed an article relative to growth in cities and public transportation and leveraging the Tacoma Link extension. Ms Beard and Mr. Moreno reviewed sites under construction or in the design phase, including Dystopian State Brewing, Artist and Craftsman Supply, McMenamins, Union Club, the Grand on Broadway, and Titus Will site redevelopment. Mr. Nakamura discussed the Stadium Apartments and benefits of the North Downtown Subarea Plan. Ms. Beard concluded by reviewing additional sites including, the Encompass, Hilltop Mixed-Use Center, the Kellogg Sicker Pochert, Hilltop Lofts, Valhalla Hall and potential TOD sites.

Discussion ensued throughout regarding parking in the Stadium District, the Transfer of Development Rights Program, long term vision, increasing commercial and office space development, privately owned properties, leveraging TOD, reducing offsite improvement requirements, tax incentive programs, City assistance for local investors, jobs, economic development strategies, streamlining regulations, eliminating large parking structures, economy, and policy strategies.
