For the week of February 12 – 16, 2024, staff visited fourteen locations. This resulted in forty-six (twenty new, twenty-six repeat) individuals being contacted and referred to community services, five individuals accepted shelter.

This workshop, tailored for multi-family managers, owners, and individuals in the landlord business, is offered free of charge.

To secure a spot, interested participants are required to RSVP via email by Friday, April 12, 2024, as we can accommodate a maximum of 250 attendees. The primary focus of the workshop revolves around public safety and addressing quality of life issues. A brief presentation on the New TPD Dashboard will be a key highlight, providing attendees with the ability to access select criminal offenses and 911 calls in close to real-time within Tacoma.

Furthermore, the workshop will feature the presence of various local, state, and federal law enforcement agencies. Their participation aims to enhance the discussion on public safety matters. In a significant collaboration, local nonprofits will also be actively engaged in the workshop, contributing their invaluable expertise to address quality of life issues specific to Tacoma. 10. Acting Planning and Development Services Director Brian Boudet provides the attached memorandum regarding proposed local amendments to Tacoma Municipal Code Titles 2 and 3 for the Building and Fire Development Codes. These changes are meant to align the City's building codes with the Washington State adoption of the 2021 building codes originally scheduled for an effective date of July 1, 2023. Concerns over potential legal challenges to the 2021 Washington State Energy Code led the State Building Code Council to vote several times to delay adoption, with the final vote delaying the effective date to March 15, 2024. Additional delays at the State Building Code Council are not anticipated and the proposed ordinance is ready for first reading on February 27, 2024, with a proposed effective date of March 18, 2024.

11. Charter Review Committee Meeting Updates:

- February 15, 2024: The Charter Review Committee (CRC) heard a presentation on the Citizen Commission on Elected Salaries from City of Tacoma Assistant Human Resources Director, Kari Louie. City of Tacoma Deputy City Attorney Martha Lantz also provided a presentation on potential inconsistencies with the Charter and current law related to salary issues. Several issues were discussed regarding the City Council and Mayor's provisions of the Charter, no decisions or recommendations were made at this meeting. The meeting ended with a discussion of the public meeting on February 26, 2024, and public outreach for the meeting, as well as some additional discussion of communications amongst members of the CRC.
- February 19, 2024: There was no meeting due to President's Day Holiday. The next CRC meeting will be held on February 22, 2024, at the Tacoma Municipal Building at 5:30 p.m.
- The CRC will hold an extended public comment period on February 26, 2024, beginning at 6:00 p.m., at the Tacoma Municipal Building. Materials will be posted for each meeting, including handouts considered by the members at each meeting.

The moratorium was initially adopted on March 7, 2023, to temporarily prohibit the establishment of new or the expansion of existing underground storage tanks, metal recycling, and auto wrecking facilities within the South Tacoma Groundwater Protection District. SUMMARY AND PURPOSE:

A resolution authorizing a Council Contingency Fund expenditure of \$5,500 to sponsor Metro Park's Mosaic Arts and Cultural Festival.

COUNCIL SPONSORS:

Mayor Victoria Woodards, Council Member Sarah Rumbaugh, and Council Member Kiara Daniels

BACKGROUND:

2024 will be MOSAIC's 36th year of bringing together a kaleidoscope of dance, music, art, food, and family fun, hosted this year at Wright Park in Tacoma's Stadium District. The annual event is a long-standing celebration of what makes Tacoma unique and brings community together. For most of MOSAIC's 36 year run the City of Tacoma has been a sponsor and partner to the event.

This year's changes to our competitive funding process changed how we are supporting community events, including Mosaic. The process changed to allow for more organizations and events to receive awards but decreased the level of funding available to each organization. For 2024 MOSAIC was not prepared for a reduction in City funding for sponsorship and it created a budget gap for the event. The funding is not only important to maintain our commitment as a partner and sponsor of this long-standing event but ensuring there is appropriate levels of funding available to pay local artists and exhibitors and procuring headliner acts to perform. While this funding would support MOSAIC at traditional levels for 2024 to allow for the festival to meet its overall goals considering the funding gap, in the future MOSAIC will need to budget to what our new competitive process funding levels allow and seek funding through other avenues. The Council Contingency fund should not be utilized for repeat or ongoing events.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

MOSAIC has been hosted for over 30 years, and has worked with partners, vendors, steering committees, and the Parks Board Members to shape the event over those many years. Metro Parks has also worked with partners to reimagine how MOASIC was promoted and branded when the event was called "Ethnic Fest". They solicited recommendations from their Steering Committee which oversees the curation of the event and is made up of community members and organizations like APCC, Bridge Latino, the Juneteenth Organizers, Tacoma's Rainbow Center, Tacoma's Urban League and others to ensure a diverse view of the event as it continues to evolve each year.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

MOASAIC brings different groups, people, communities, and cultures all coming together to celebrate as one. The Mosaic event isn't just an event for this culture or that nationality. It is a showcase of all the people of Tacoma. It highlights not only the strong cultural traditions and diversity of our city but brings people from all over Tacoma into one space to connect, share stories, and highlight who make Tacoma home.

I ask for your support for a \$5,000 Council Contingency Request to sponsor the Moroccan Sister City Committee Cultural and Economic Exchange

LEGISLATIVE INTENT:

Council Contingency Fund Request: The Sister Cities Council of Tacoma advances Tacoma as a global city and promotes peace through mutual respect, understanding, and cooperation through citizen diplomacy – one individual, one community at a time – for the benefit of Tacoma and its sister cities. To accomplish its mission, The Sister Cities Council of Tacoma develops programs in the areas of cultural arts and tourism, global education, government relations, and international business.

El Jadida has been Tacoma's Sister City since 2007 and shares many characteristics that make our communities ripe for cultural and economic exchange. El Jadida is a port city on the Atlantic coast of Morocco, in the province of El Jadida. El Jadida has a beautiful and long coastline that attracts over 10 million visitors from around the world each year. It has a population of about 220,000 and is the port for Marrakech and other Moroccan cities.

In 2024 the El Jadida Sister City Committee will be traveling to Morocco to build relationships with our Sister City and exploring future partnerships that might be available to increase our cultural and economic exchanges with our Sister Port City. This funding would support the overall trip and allow more of the members to travel and allow for more opportunities while in Morocco to connect with the people, businesses, and agencies that can open future opportunities for exchanges between Tacoma and El Jadida. While we have had an ongoing Sister City relationship for many years, this is the first active Committee committed to engaging El Jadida since the early years, and the support of this reconnection with El Jadida is a welcomed opportunity. In the future the Tacoma Sister City board and El Jadida Committee members will need to explore other regular funding sources or sponsorships to support future missions rather than rely on the Council Contingency Fund.

FUNDING REQUESTED:

\$5,000

COMMUNITY ENGAGEMENT/ (CUSTOMER RESEARCH):

Each Sister City Committee is led by volunteers who choose to support that relationship that Tacoma has either because of interest or personal experience with that Sister City. These

volunteers do a lot of work reaching out to their communities to get residents who may be form those Sister Cities or countries to engage and volunteer time to build those relationships.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

The efforts of the Tacoma Sister Cities organization focus on programs and exchanges that further economic collaboration and cultural understanding between communities. This allows volunteers on Sister City Committees and residents who engage in their programs to gain a better understanding and appreciation of other cultures which in turn may allow for better engagement and understanding locally with those of different backgrounds and experiences.

Civic Engagement: *Equity Index Score*: Moderate Opportunity

Increase the number of residents who participate civically through volunteering and voting. Increase the percentage of residents who believe they are able to have a positive impact on the community and express trust in the public institutions in Tacoma.

Explain how your legislation will affect the selected indicator(s)?

Sister Cities is a volunteer organization, and the members who give their time choose to do so often give their time to other civic opportunities and are more engaged in Tacoma. They also have a better grasp of where to engage to make an impact and have stronger feeling of satisfaction that they are making positive impacts and more trust in the agencies around them.

SUMMARY AND PURPOSE:

Confirming the appointment of Chantell Harmon Reed as the Director of Health for the Tacoma-Pierce County Health Department, to begin March 18, 2024.

COUNCIL SPONSORS:

Mayor Victoria Woodards

BACKGROUND:

Under the interlocal agreement that was approved by City Council Resolution 36734 on December 13, 2005, and County Council Resolution R2006-30 approved May 30, 2006, the Mayor and County Executive have joint authority to appoint the director of Health. Following that appointment pursuant to RCW 70.08.010 through 70.08.040 the City and County Councils then must pass resolutions to confirm the appointment.

Following the retirement of Dr. Anthony Chen in 2023, the Tacoma Pierce County Health Department Board members initiative a national search for a new director. This is the first opportunity to confirm a Director of Health since former Director Dr. Anthony Chen was initially confirmed in 2008.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

The Tacoma Pierce County Board of Health under the Leadership of Board Chair Catherine Ushka has designed and implemented a thorough and intentional national recruitment to find a slate of finalists to present to Mayor Woodards and County Executive Dammeier. Through this process they interviewed and narrowed down a long list of candidates to ensure a strong selection to lead the health department.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

Confirming a Director of Public Health will ensure strong leadership of our regional health authority and allow a new leader to bring their diverse experience and expertise to Tacoma and Pierce County to advocate and ensure the health of our communities.

SUBJECT: Local Amendments to Building and Fire Codes

DATE: February 22, 2024

OVERVIEW

On February 27, 2024, the City Council is scheduled to hear first reading of an ordinance to adopt proposed amendments to Tacoma Municipal Code (TMC) Titles 2 and 3 for the Building and Fire Development Codes. The ordinance was expected to come before the City Council in June 2023, but was held back due to delays in the adoption of the Washington State Building Code, upon which this local ordinance is based. Recognizing this ordinance is coming before the City Council after a significant gap in time from when this issue was discussed at the Infrastructure, Planning, and Sustainability (IPS) Committee in May of 2023, staff is providing information to assist with refamiliarizing the City Council with the updates to the Building and Fire Development Codes.

BACKGROUND:

Planning and Development Services (PDS) presented the proposed changes to TMC Titles 2 and 3 to the IPS Committee on May 10, 2023. These changes are meant to align the City's building codes with the Washington State adoption of the 2021 building codes originally scheduled for an effective date of July 1, 2023.

Concerns over potential legal challenges to the 2021 Washington State Energy Code led the State Building Code Council to vote to delay adoption. A vote on May 24, 2023, delayed the effective date of the 2021 codes to October 29, 2023. A second vote on September 15, 2023, delayed the effective date to March 15, 2024.

The delays allowed the State Building Code Council to enter rulemaking to modify sections in the commercial and residential energy codes to address legal uncertainty stemming from the decision in California Restaurant Association v. City of Berkeley recently issued by the Ninth Circuit Court of Appeals.

PDS has not modified the proposed ordinance since our presentation to IPS last year. Additional delays at the State Building Code Council are not anticipated and the proposed ordinance is ready for first reading on February 27, 2024, with a proposed effective date of March 18, 2024.

NOTABLE CHANGES:

The forthcoming State Building and Energy Codes include revised electric vehicle charging infrastructure requirements, updates to the State Energy Code for both residential and commercial construction, provisions for new technologies such as energy storage systems, provisions for All Gender Facilities, and new requirements for High-Rise Building Fire Sprinkler retrofits.

TMC Titles 2 and 3 are updated to provide protections for neighboring properties during construction and provide clarity on encroachments. TMC 2.22 Right-of-Way Development Code is updated to provide clarity and uniformity with the requirements in Title 10 Public Works and Title 13 Land Use Regulatory Code. The political sign code provisions previously located in TMC 2.05 have been removed entirely while retaining existing regulations in Title 13.
