## **Briefing Items**

4. 24-1006 Transportation Master Plan Update

[Carrie Wilhelme, Principal Transportation Planner, Public Works]

At approximately 4:33 p.m., Carrie Wilhelme, Principal Transportation Planner, Public Works, presented the Transportation Master Plan (TMP) update, including agenda; Comprehensive Plan and the TMP, noting policy elements or chapters; contents of the TMP, noting Growth Management Act mandates; TMP modal and functional elements, vision or outcomes for each; vision for the final document, noting the main document and appendices; engagement and feedback, noting the 2024 community survey; draft updated TMP vision statement; vision statement and goals; work underway; and the timeline.

Discussion ensued regarding the last TMP update; multimodal transportation, noting implications of how people are going to work, parking, emergency services, and loading zones in all neighborhoods; pedestrian safety; how to connect with all networks; safe co-use of spaces; small goods delivery; time frame of the TMP; tree and vegetation management; parking lots; long and short range goals; park and ride locations; tracking and performance measures; and the green transportation hierarchy.
