Call to Order

Mayor Strickland called the study session to order at 12:07 p.m.

Briefing Items

1. 16-0126 Environmental Action Plan

At approximately 12:08 p.m., Jim Parvey, Assistant Division Manager, Office of Environmental Policy and Sustainability (OEPS), provided opening remarks regarding the draft Environmental Action Plan. He then introduced Kristin Lynett, Manager, OEPS. Ms. Lynett reviewed the six categories the plan is divided into, the plan's framework, baseline indicator, five year targets, public input, and next steps.

Discussion ensued regarding air pollution, community gardens in low income neighborhoods, the importance of tracking demographics, electric and plug-in hybrid City vehicles, public transportation, tracking of green house gas emissions in early 2017, and green house gas inventory.

2. 16-0127 Treatment Plan for the Asian Gypsy Moth Threat

At approximately 12:46 p.m., Mr. Parvey provided opening remarks regarding the destructive gypsy moth population and the 2016 recommended treatment in the City. He then introduced Hector Castro, Communications Director, and Dr. Brad White, Assistant Director, Plant Protection Division, Washington State Department of Agriculture. Dr. White reviewed where the moths were found, what's at risk, and the recommended treatment. Mr. Castro reviewed the public outreach effort.

Discussion ensued regarding the safety of the pesticide, start date and

timeframe for the spraying, methods to get the word out to City residents, such as, TV Tacoma and meeting with business owners and longshoremen.

3. <u>16-0129</u> Council Consideration Request - Welcoming Cities Latino Roundtable Community Convenings

At approximately 1:15 p.m., Council Member Campbell presented a Council Consideration Request for up to \$10,000 from the Council Contingency Fund for the facilitation of two townhall meetings to connect with member's of the Latino community as part of the Welcoming Cities Initiative.

Discussion ensued regarding how this came about, the intended outcome, cost, and welcoming undocumented community members.

4. <u>16-0128</u> Weekly Report to the City Council, February 11, 2016
