



## RESOLUTION NO. 40533

1 A RESOLUTION relating to the vacation of City right-of-way; setting Thursday,  
2 February 20, 2020, at 1:30 p.m., as the date for a hearing before the City of  
3 Tacoma Hearing Examiner on the petition of The Humane Society for  
4 Tacoma and Pierce County, to vacate a portion of the alley lying between  
5 South 67th Street and South 69th Street, and west of South Adams Street,  
6 to facilitate future development.

7 WHEREAS The Humane Society for Tacoma and Pierce County, having  
8 received the consent of the owners of more than two-thirds of the properties  
9 abutting the alley lying between South 67th Street and South 69th Street, and  
10 west of South Adams Street, has petitioned for the vacation of the following  
11 legally described right-of-way area:

12 A PORTION OF THE ALLEYWAY BETWEEN SOUTH 67TH AND  
13 SOUTH 69TH STREETS, SOUTH ADAMS STREET AND  
14 VACATED DURANGO STREET, MORE PARTICULARLY  
15 DESCRIBED AS FOLLOWS:

16 THE 20 FOOT WIDE ALLEYWAY LYING BETWEEN AND  
17 ABUTTING LOTS 3 THROUGH 21, BLOCK 24 AND LOTS 3  
18 THROUGH 21, BLOCK 25, PLAT OF VILLA PARK, FILED  
19 AUGUST 4, 1890, AT VOLUME 5, PAGES 60 AND 61,  
20 RECORDS OF PIERCE COUNTY, WASHINGTON.

21 ALL SITUATE IN THE CITY OF TACOMA, COUNTY OF  
22 PIERCE, STATE OF WASHINGTON; WITHIN THE NORTHEAST  
23 QUARTER OF SECTION 25, TOWNSHIP 20 NORTH, RANGE 2  
24 EAST OF THE WILLAMETTE MERIDIAN.

25 Now, Therefore,

26 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

Section 1. That Thursday, February 20, 2020, at 1:30 p.m., is hereby  
fixed as the date and time, and the Council Chambers on the first floor of the  
Tacoma Municipal Building, 747 Market Street, in the City of Tacoma, as the

 2 his recommendations thereafter transmitted to the Council of the City of  
 3 Tacoma.

4 Section 2. That the Clerk of the City of Tacoma shall give proper notice
