1 BY REQUEST OF MAYOR WOODARDS

2 A RESOLUTION relating to committees, boards, and commissions; appointing

14 Mayor Woodards strives to balance City Council committee, board, and  
15 commission assignments based on a number of criteria, including the number of

18 regulations, and procedures of the City Council, the City Council Members  
19 named on Exhibit "A" have been nominated to serve on said committees,
