A RESOLUTION related to the purchase of materials, supplies or equipment, and the furnishing of services; authorizing the appropriate City officials to enter into a contract with Pierce County Security, Inc., in the amount of \$102,600.00, sales tax not applicable, for a cumulative total of \$404,342.50, budgeted from the Non-Departmental General Fund, to increase the contract for security guard services for the Tacoma Municipal Building and Tacoma Municipal Building North through May 31, 2014.

RECOMMENDATION: The Public Works Department requests approval to increase Contract No. 4600005596 to Pierce County Security, Inc., Tacoma, WA, by \$102,600.00, sales tax not applicable, for additional services. This increase will bring the contract to a cumulative amount of \$404,342.50, sales tax not applicable.

EXPLANATION: The increase to this contract will provide a full time presence in the 1st and 2nd floor lobbies of the Tacoma Municipal Building and enhance customer service levels for visitors.

COMPETITIVE BIDDING: This contract was originally awarded to Pierce County Security, Inc. as a result of Request for Bids Specification No. PW09-0130F in May 2009. The contractor has agreed to increase the contract for the additional services for the remaining term of the contract through May 31, 2014.

CONTRACT HISTORY: After issuing Request for Bids Specification No. PW09-0130F, on May 12, 2009, Facilities Management, under Purchase Resolution No. 37791, recommended award for a two year contract in the amount of \$120,697.00, sales tax not applicable, plus the option to renew for three additional one-year renewal periods (cumulative total of five years), for an aggregate amount of \$301,742.50, sales tax not applicable. Since the initial two year term expired May 31, 2011, three separate amendment/renewals have been executed annually in order to extend the contract and increase the cumulative dollar amount. This increase will bring the contract to a cumulative amount of \$404,342.50, sales tax not applicable, for services through May 31, 2014. This is the fourth amendment to the contract.

FUNDING: Funds are available in the General Fund 0010, Non-Departmental.
