SUMMARY:

Request to extend the Tacoma Police Facilities Internal note of \$4.2M an additional five years to November 28, 2018.

BACKGROUND:

In 2002, Tacoma Voters approved \$34.3 million in bonds to construct a Tacoma Police Headquarters and four neighborhood substations. Due to major escalations in the cost of construction to complete the headquarters and the bids for the substations, which came in much higher than anticipated, additional funding was required to complete the headquarters and four neighborhood substations.

In October 2005, the City Council passed Ordinance 27415 to provide additional funding of \$4.200,000 by issuance of an Internal Note. The Internal note provided additional funding for the police headquarters and four neighborhood substations. Repayment of the note was secured by the sale of City-owned property located at 21s Street and Jefferson Avenue. The sale of the property has not materialized. It has been determined that a later sale would be advantageous to the City and that the note due date should be extended for an additional five years from November 28, 2013 to November 28, 2018.

ISSUE:

The Internal Note is due on November 28, 2013 and the sale of the property that secures the internal note has not materialized.

ALTERNATIVES:

No other alternatives.

RECOMMENDATION:

To approve the Internal Note extension for an additional five years to November 28, 2018 or until the property that is securing the note has been sold.
