 Tower Crane Notifications and Permitting

 [Chris Seaman, Engineering Manager, Planning and Development Services]

At approximately 4:58 p.m., Chris Seaman, Engineering Manager, Planning and Development Services, presented the proposed amendments to tower crane notifications and permitting, including an overview, noting a new Tacoma Municipal Code (TMC) Chapter 2.23; background; issues; proposed revisions, noting TMC Chapter 2; health, equity, and sustainability analysis; outreach; next steps; and recommendations.

Discussion ensued regarding the definition of a tower crane, land use permitting, enforcement, and impact on businesses in the area of right of way.

MOTION: Vice Chair Diaz moved to forward the proposed amendments to Title 2 of the Tacoma Municipal Code related to Tower Cranes and Permitting and creating a new Chapter 2.23, to comply with changes to the Revised Code of Washington, to the full City Council for consideration.

ACTION: Voice vote was taken and carried. The motion was declared adopted.

3. <u>24-0946</u> Climate Commission Proposed Charter Amendment [Chair Walker]

At approximately 5:15 p.m., Chair Walker provided opening remarks and background on the proposed amendments to the City Charter related to forming a Climate Commission, including a name change of the Sustainable Tacoma Commission (STC), number of members on the Commission, and the proposed carbon budget.

Discussion ensued throughout regarding liaisons between commissions, renaming of the STC, number of members on the Commission, staff requirements, use and cost of establishing a carbon budget, carbon credits, and climate impact.
