Subject: Fiscal Impact of IBEW Local 483 Clerical Unit Wage Increase for 2013 & 2014

#### Overview

The following provides a financial analysis for wage increases for IBEW Local 483 Clerical Unit effective January 1, 2013 and January 1, 2014

## **Fiscal Impact Assumption for 2013**

Effective January 1, 2013 wage rates for the following classifications have been negotiated to increase by 1.8%.

# **Funding for 2013**

The total estimated cost in 2013 for salaries and wages for IBEW Local 483 Clerical Unit including the increases discussed above is \$13,920,288 (\$5,003,039 General Fund, \$1,926,470 General Government Utilities, \$3,217,219 other general government funds, \$3,910,101 Tacoma Public Utilities). The total cost of the negotiated increase is included in the 2013-2014 Budget.

# **Fiscal Impact Assumption for 2014**

Effective January 1, 2014 wage rates for IBEW Local 483 Clerical Unit have been negotiated to increase by 2.0%. This rate is equal to 100% of the increase in the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W), Seattle-Tacoma area.

The following estimated expenses include the incremental cost by fund for the wage rate increase and includes the cost of benefits tied to salary. Benefits that are a fixed dollar amount will not change due to salary increases but are included in the estimated expense.

#### Funding for 2014

The total estimated cost in 2014 for salaries and wages for IBEW Local 483 Clerical Unit including the 2.0% increase discussed above is \$14,758,945 (\$5,282,131 General Fund, \$2,043,931 General Government Utilities, \$3,406,808 other general government funds, \$4,026,075 Tacoma Public Utilities). The total cost of the negotiated increase is included in the 2013-2014 Budget.
