Citizens' Forum ended at 5:49 p.m.

City Manager T.C. Broadnax provided information on the public process and requirements of the sand and gravel mining project that was referenced during Citizens' Forum. He stated there will be a public information meeting on January 12, 2017 and public comment, including requests for an environmental determination of significance, an environmental impact statement (EIS), compliance, and concerns will be accepted through January 27, 2017.

City Attorney Elizabeth Pauli stated her office has reached out to the Assistant Attorney General that represents the Department of Ecology to discuss their position on a supplemental environmental impact statement (SEIS). She stated staff is hopeful that in short order there will be a writing that reflects the Department of Ecology's position on lead status and the status of a possible SEIS, which will be made available to the public when received.

Council Member Campbell discussed pending work at the Board of Health, including a potential health impact statement for projects.

Council Member Mello encouraged everyone interested to submit their public comments and requests for an EIS as part of the public process for the mining project. He then responded to a comment regarding his role on the Board of the Puget Sound Clean Air Agency, noting the Board does not vote on any permits, and he is happy to bring forward any questions to the agency.
