PURPOSE: To amend the above-referenced agreement (AGREEMENT) between the state of Washington Department of Ecology (ECOLOGY) and City of Tacoma ES Department (RECIPIENT) for the Madison and Monroe Permeable Neighborhood (PROJECT).

This amendment is needed to: Extend the Expiration Date from 12/31/2018 to 06/30/2019 to allow the RECIPIENT to finish constructing the facility. The project has been under construction since May of 2018, but due to existing soil conditions and utility conflicts, construction is taking longer than expected. Construction is now expected to be completed within 3 months.
