1. Call to Order

5:04 pm (00:04)

Chair Shakoor called the meeting to order. Chair Shakoor recognized that the meeting was held on Indigenous land: the traditional homelands of the Puyallup people.

2. Consent Agenda (00:38)

3. Chair's Report/Housekeeping (02:40)

Chair Shakoor, Vice Chair Brown, and staff met with Councilmember Scott to discuss the role of Council Liaison on the Commission. Councilmember Scott will have a quarterly standing time on the Commission agenda starting in June.

4. Public Comment on Agenda Items (03:45)

There were no public comments on agenda items.

5. Presentations

a. Environmental Services Artist in Residence (04:11)

Staff introduced Teruko Nimura, who is the new Artist in Residence for the City of Tacoma's Environmental Services Department. Teruko shared samples representing her past personal artistic practice and public art projects. Teruko shared about her work so far as Artist in Residence. Teruko's initial projects include leading a hands-on activity at the Sustainability Expo and creating custom wraps for collection receptacles for Tidy Up Tacoma work.

Commissioners provided comments.

6. Action Items

a. Council Advocacy Items (30:15)

Chair Shakoor introduced the opportunity Commissioners have to advocate Council for needs to support the cultural community. Commissioners shared things they want to advocate for, and staff provided background information relevant to these items:

- Increased budget for arts funding would allow larger funding awards to be distributed through current and/or additional funding programs so creatives can be paid living wages for their work and so creatives can access physical spaces to create work.
- Public art staffing, inclusive of the transition of a current temporary position to an ongoing position and the addition of one new Public Art Project Manager position, to be able to continue managing public art projects throughout Tacoma
- Tacoma Creates reauthorization – The Commission supports the reauthorization of Tacoma Creates.
- Tacoma Public Utilities' participation in the 1% for Art program

Commissioners discussed and asked questions.

Chair Shakoor asked for a motion to approve an advocacy item in support of public art staffing, specifically to renew Ricky Reyes position and add one additional Public Art Project Manager position.

There was a motion: "I would move that we support this as one of the advocacy items we talk to in our Council Coffees."

- Looking at the Tacoma Municipal Code for requirements of Commission funding programs and ways to address needs while working within the code.
- Contracts for cultural services require public benefit with public funds
- Discussion of various needs of creatives
- Looking at other City funding programs to see how they complement Commission funding and where there are gaps

The subcommittee will start working on:

- Identifying general gaps/needs in the Commission’s existing funding programs
- Looking at current Commission funding programs and ways to adjust them to address gaps/needs identified

c. 2023 Annual Report Overview (1:06:05)

Staff shared the Arts & Cultural Vitality Division’s 2023 Annual Report, highlighting the Arts Overview and ‘Impact by Council District’ sections, inclusion of quantitative and qualitative data through quotes and photos, links to videos, an overview of the Arts & Economic Prosperity 6 study, a panelist section, and a Tacoma Creates overview with a link to Tacoma Creates’ full report. Commissioners discussed.
