At approximately 3:37p.m., Chair Walker called on Stephen Antupit, Senior Planner, Planning and Development Services, to provide background on the development of the Urban Design Board. Nicole Emery, City Clerk, provided background on Ordinance No. 28966, establishing the Urban Design Board. Emery continued with informing the Committee they will be interviewing twelve applicants for seven positions, and reviewing written response from Christiano Martinez, noting the Committee interviewed Martinez on August 14, 2024, for the Transportation Commission.

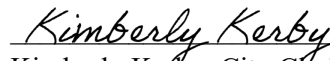
