SUMMARY AND PURPOSE:

An ordinance repealing Substitute Ordinance No. 28807 in its entirety at Petitioner's request to cancel the request for Street Vacation No. 124.1425 to vacate a portion of an alley right of way, abutting and lying south of East 30th Street, between East K Street to the west, and Valley View Terrace to the east, to allow for expanded residential yard use.

BACKGROUND:

This Department's Recommendation is Based On: Receipt of Petitioner's request to cancel Petition to Vacate Right of Way. On July 12, 2022, Substitute Ordinance No. 28807 was accepted by the City Council through final reading. The day before expiration of the statutory waiting period and before the Substitute Ordinance could be recorded and finalized by the City Clerk, the Petitioner notified the City of the request to cancel the street vacation petition. A refund of the market value payment was issued to the Petitioner.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

Petitioner, who is a community member, has requested that their street vacation petition be cancelled. Petitioner is the only one affected by this proposal. No further engagement and/or research conducted.
