A. Call to Order

Chair Karnes called the meeting to order at 5:00 p.m. A quorum was declared.

Chair Karnes read the Land Acknowledgement.

B. Approval of Agenda

Vice-Chair Steele moved to approve the agenda as submitted. Commissioner Krehbiel seconded the motion. The motion passed unanimously.

C. Approval of Minutes

There were no meeting minutes to approve.

D. Public Comments

Stephen Atkinson, Principal Planner, reported that there were no written comments received for public comment.

No individuals addressed the Planning Commission.

E. Disclosure of Contacts and Recusals

There were no disclosures of contacts or recusals.

F. Discussion Item

1. One Tacoma Comprehensive Plan Update – Environment (Part 2)

Maryam Moeinian, Senior Planner, presented the Environment and Watershed Health Element of the One Tacoma Comprehensive Plan, including the update timeline, GMA requirements, critical areas protection, an overview of the current Element, an outline of proposed updates, community feedback, climate change risks, urban heat and air pollution policies, tree canopy coverage policies, the Climate Ready Urban Landscape and Habitat Strategy (CRULHS), and CRULHS alignment with One Tacoma.

Discussion ensued regarding how sea level rise affects prioritizing trees, tree retention encouragement, workforce development within critical areas and open spaces, net-gain, the canopy cover goal, community engagement, other vegetation options, the critical areas maps, the climate legislation, protections for vulnerable populations, wildfire risk, ambient noise-level tracking, encouraging native plants, and the nomenclature of "urban landscape" versus "urban forest".

The Planning Commission recessed at 6:12 p.m. and reconvened at 6:17 p.m.

2. One Tacoma Comprehensive Plan Update – Engagement

Alyssa Torrez, Senior Planner, presented the Engagement and Administration Element of the One Tacoma Plan, including planning goals, the importance of engagement practices, an overview of key updates, and next steps.

Discussion ensued regarding community events; timeline, radius, and language of mailing notices; accessibility of the city website; engagement exhaustion; meeting conflicts; and vulnerable groups and trauma-informed practices.
