## **Briefing Items**

**1. 24-0926** 2025 Consolidated Plan

[Taylor Palmer Jenson, Senior Housing Analyst, Community and Economic Development]

At approximately 4:34 p.m., Taylor Palmer Jenson, Senior Housing Analyst, Community and Economic Development, present the 2025 Consolidated Plan, including background, noting components of the Consolidated Plan, Annual Action Plan, and consolidated annual performance and evaluation report; issues, noting eligible activities for programs covered by the Consolidated Plan, needs for affordable housing and human services, and most important issues by neighborhood outreach; and next steps.

Discussion ensued regarding confirmation that the plan was annual with a five year term; advocacy is needed for reaching out to the federal government and the concerns with funding; how is Housing and Urban Development involved; eligible activities; the anti-displacement program through home repair; shared housing funds and grant clarification; compliance; emergency grants for homelessness; and the homelessness management system.

2. <u>24-0927</u> Tacoma Area Commission on Disabilities Interviews [Nicole Emery, City Clerk]

At approximately 4:51 p.m., Nicole Emery, City Clerk, provided background regarding the Tacoma Area Commission on Disabilities (TACOD) interviews, informing the committee they will be interviewing two applicants; and will be reviewing applications for two commissioners seeking reappointments; and currently there are four positions available.

Discussion ensued regarding the qualifications of the applicants' seeking reappointment.

MOTION: Vice Chair Walker moved to recommend the reappointment of Lukas Barfield to the Tacoma Area Commission on Disabilities to serve a three-year term, retroactive to September 1, 2024, to expire August 31, 2027.
