Briefing Items

1. 14-0251 P3 Partnerships - Public Safety

Mayor Strickland announced the first study session topic is the Tacoma Fire and Police Department's Public Private Partnerships (P3). Tacoma Police Chief Don Ramsdell reviewed the Police Department's mission and community partnerships.

Council Member Walker arrived here, at 12:13 p.m.

Chief Ramsdell reviewed the Police Department's goals and objectives, and law enforcement partners.

Council Member Lonergan arrived here, at 12:18 p.m.

Chief Ramsdell continued to review law enforcement partnerships, health and education partners, and next steps. Discussion ensued regarding data related to car thefts, partnerships with Bates Community College, bicycle patrols, potential business district partnerships, sector patrols, and ways to prevent property crime. Council Member Lonergan requested information regarding car theft data and recovery rates.

Mayor Strickland called upon Jim Duggan, Fire Chief to review the Fire Department's mission statement. Chief Duggan reviewed their goals and objectives, community partners, environmental hazards, and next steps. Discussion ensued regarding smoke and carbon monoxide detectors, funding

opportunities, and ways to promote CPR training. Mayor Strickland requested information regarding the number of homes without smoke detectors.
