



RESOLUTION NO. 40976

1 A RESOLUTION setting Tuesday, June 7, 2022, upon completion of Regular
2 Agenda Items, no earlier than 5:15 p.m., as the date for a public hearing by
3 the City Council on the proposed Six-Year Comprehensive Transportation
Improvement Program amended for the years 2022 and 2023-2028.

4 WHEREAS Section 35.77.010 of the Revised Code of Washington
5 (“RCW”) provides that the legislative body of each city and town prepare and
6 adopt a comprehensive transportation program for the ensuing six calendar
7 years, and annually thereafter, pursuant to one or more public hearings, prepare
8 and adopt a revised and extended comprehensive transportation program, and
9 each one-year extension and revision thereof will be filed with the Secretary of
10 Transportation of the State of Washington, and

12 WHEREAS the City adopted the Transportation Master Plan (“TMP”) in
13 December 2015, which includes a prioritized list of transportation projects, and
14 included extensive Citywide community outreach, including attendance at
15 neighborhood festivals and clean-ups, and two public hearings; the proposed list
16 of projects to be added to the draft Six-Year Comprehensive Transportation
17 Improvement Program (“Program”) supports the goals and policies, as well as
18 network priorities outlined in the TMP, and

20 WHEREAS, City staff provided a presentation to the Infrastructure,
21 Planning, and Sustainability Committee on the proposed list of projects to be
22 added to, removed from, or consolidated with other projects in the draft Program
23 on March 23, 2022, and a presentation on the full draft Program on April 27, 2022,

2 Commission on the proposed list of projects to be added to, removed from, or
3 consolidated with other projects in the draft Program on March 16, 2022, and a
4 presentation on the full draft Program on April 20, 2022, and additionally, staff
5 presented the proposed list of projects to be added to, removed from, or
6 consolidated with other projects in the draft Program at the May 10, 2022, City
7 Council Study Session; Now, Therefore,
