#### **SUMMARY AND PURPOSE:**

An ordinance amending Title 6 of the Municipal Code, relating to Chapters 6B.10 – General License Provisions and 6B.20 – Annual Business License, 1) decrease the late filing penalty on business license fees, 2) strengthen license requirements and enforcement tools and 3) clarify administrative provisions of the licensing code and relating to general clean-up of language throughout Title 6.

#### **BACKGROUND:**

The Finance Department's Tax & License Division recommendation is based on a comprehensive review of Title 6. An extensive review is conducted approximately every five years to ensure code language is clear in application, up to date with current practice and administratively workable. Additionally Substitute Ordinance #28838 that was passed in December 2022 added two new business licensing tiers and increased business license fees in 2023 and 2024, substantially increasing the amount of penalty assessed on business license fees paid after the due date.

## **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

All licensed businesses will be notified of the changes to the penalty structure with the annual license renewals which occurs in December. Expansion of the criminal background check to include federal and state results will be communicated to applicants as new license applications are submitted.

#### **2025 STRATEGIC PRIORITIES:**

#### Equity and Accessibility: (Mandatory)

Review of the Tax & License code on regular intervals allows staff to use equity and bias training to review the code through an equity lens. While many sections pertain to requirements on businesses and administrative functions, reviewing these through an equity lens allows for removal or changes to code language that would impact the City's equity and anti-racist efforts.

## STAFF/SPONSOR RECOMMENDATION:

Staff recommends Council pass the Ordinance to 1) decrease the penalty on license fees when paid after the due date, 2) strengthen license requirements and enforcement tools and, 3) clarifying administrative provisions of the licensing code and relating to general clean-up of language throughout Title 6.

### FISCAL IMPACT:

There will be an estimated decrease to the General Fund in 2024 of \$200,000 if the license penalty is amended from 50% to 20%. Additionally changing the tier 1 license fee from \$37.50 to \$37 decreases the estimated revenue to the General Fund by \$2,000.
