SUMMARY AND PURPOSE:

A resolution declaring surplus and authorizing the execution of a Development Agreement and a Quit Claim Deed to convey vacant undeveloped residential property at 912 S 25th Street to the Tacoma Ministerial Alliance.

BACKGROUND:

This Department's Recommendation is Based On: This property transfer aligns with the City's goals of utilizing surplus property for affordable housing. This project will consist of six units an each of them will be affordable homeownership units available to low-income households. The Tacoma Ministerial Alliance was identified through a direct negotiation process in 2023. The project scope has been finalized and the developer's private construction financing for the project has been secured.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

In accordance with the 2019 City Policy for the Sale/Disposition of City-owned Real Property, this surplus property was offered to the Puyallup Tribe of Indians for consideration of their first rights of refusal and was determined not to meet their current needs for acquisition.

There has not been any direct engagement with the community on this property however, affordable housing is a consistent need voiced by the community; the development aligns with the City's Affordable Housing Action Strategy under the Objective 1, Create More Homes for More People.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

The Tacoma Ministerial Alliance asserts that it works closely with Black churches in Tacoma and will use these connections as part of the overall marketing strategy to find eligible buyers for the units that are developed. This would be seen as a successful affirmative marketing strategy that involves targeted outreach and advertising for the available units in a manner that households least likely to find out about the units are directly engaged with. The need for more units and resources targeted toward Black households was a recommendation from the City's 2021 Homeownership Disparity Study and this project will advance efforts to address that recommendation. All of the units will be restricted to buyers having an income that is at or below 80% area median income (AMI). This advances the City's efforts to increase the availability of affordable homeownership units in the City.
