



RESOLUTION NO. 40362

1 A RESOLUTION relating to the Tacoma-Pierce County Employment Training
2 Consortium (“WorkForce Central”); authorizing the execution of an
3 amendment to the agreement with WorkForce Central for a market-based
4 interest bearing line of credit, in an amount not to exceed \$250,000,
5 budgeted from the General Fund, for an additional two-year period, through
6 December 31, 2021.

7 WHEREAS the City, in conjunction with Pierce County (“County”), created
8 the Tacoma-Pierce County Employment Training Consortium (“WorkForce
9 Central”) by Interlocal Agreement on October 1, 1982, and
10

11 WHEREAS Section 12 of the Interlocal Agreement states that the City and
12 County accept the ultimate responsibility for the operation and success of
13 WorkForce Central, and
14

15 WHEREAS the majority of funding for WorkForce Central comes from
16 federal sources on a reimbursable basis, and
17

18 WHEREAS ongoing fiscal discussions at the federal level could result in
19 short-term interruption of reimbursements to WorkForce Central, and
20

21 WHEREAS Resolution No. 39821, adopted on September 26, 2017,
22 authorized the execution of an agreement with WorkForce Central for a market-
23 based interest bearing line of credit, in an amount not to exceed \$250,000, for the
24 period of January 1, 2018, through December 31, 2019, to ensure that program
25 services would not be disrupted, and

WHEREAS, at the same time, WorkForce Central also requested, and was
approved for, a \$250,000 line of credit from the County for this purpose, and

WHEREAS WorkForce Central is requesting a two-year extension of both
lines of credit, through December 31, 2021, and

WHEREAS the City desires to ensure the employment training services provided by WorkForce Central to continue to be provided without interruption, and

WHEREAS City staff is recommending that the line of credit be extended for an additional two-year period and bear interest at a market rate of interest to be determined at the time of execution of the extension; Now, Therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

That the proper officers of the City are hereby authorized to enter into an amendment to the agreement with the Tacoma-Pierce County Employment Training Consortium (“WorkForce Central”), for a market-based interest bearing line of credit, in an amount not to exceed \$250,000, budgeted from the General Fund, for an additional two-year period, through December 31, 2021, said amendment to be substantially in the form of the document on file in the office of the City Clerk.
