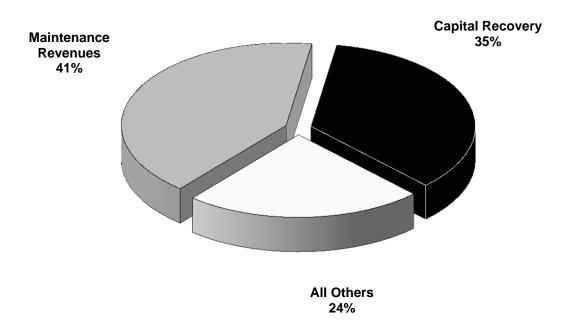

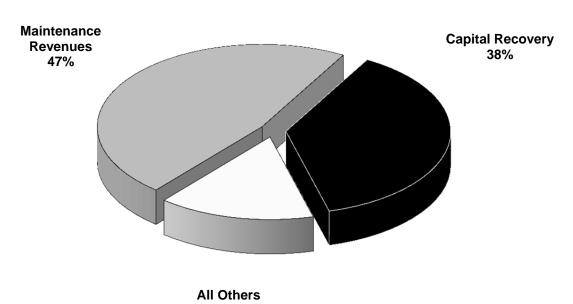

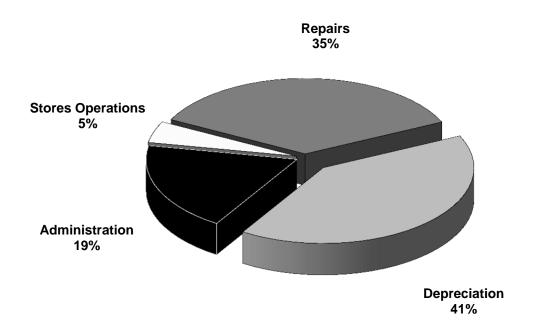
# TOTAL OPERATING REVENUES Year to Date - August 2013 (\$3,396,632)
