Public Safety, Human Services, and Education Committee

Council Member Woodards, Chair of the Public Safety, Human Services, and Education Committee, stated the January 8, 2015 meeting included a presentation on the Youth and Young Adult Crisis Center and Emergency Shelter Project, a review of the Committee's 2014 Annual Report, and a discussion on the Committee's 2015 work plan. She then stated the February 26, 2015 meeting included a presentation on animal retail within City limits. Council Member Woodards noted the Committee heard three presentations on March 26, 2015 related to the 2015-2016 Community Development Block Grants and Emergency Solutions Grant funding for the Annual Action Plan, proposed changes to smoking on municipal transit property, and proposed changes to the Municipal Code relating to airsoft weapons. She concluded by announcing the next meeting is scheduled for April 9, 2015, and will include the 2014 report from the Human Rights Commission, and the Region 5 All Hazards Mitigation Plan.
