STRATEGIC POLICY PRIORITY:

This item best aligns with the strategic priority policy related to encouraging and promoting an open, effective, results-oriented organization by allowing the voters of the City of Tacoma to choose how the Charter should be amended.

City of Tacoma

BACKGROUND:

On November 12, 2013 the City Council adopted Resolution No. 38773, creating a Charter Review Committee for the purpose of reviewing the existing Charter of the City of Tacoma. The Committee finished its review and submitted its recommendations to the City Council on May 6, 2014. The City Council reviewed the recommendations at a special meeting of the City Council on June 17, 2014, and advanced 12 amendments to the City Charter for consideration as resolutions at the regular City Council meeting on July 15, 2014.

At the July 15, 2014 City Council meeting, Resolution Nos. 38948, 38949, 38950, 38951, 38953, 38957, 38958 and 38959; and Amended Resolution Nos. 38952, 38954, 38955, and 38956 were adopted for submission to the voters of the City of Tacoma at the special municipal election to be held on November 4, 2014. Per RCW 29A.32.280, for each measure from a unit of local government that is included in a local voters' pamphlet, the legislative authority of that jurisdiction shall, not later than forty-five days before the publication of the pamphlet, formally appoint a committee to prepare arguments advocating voters' approval of the measure and shall formally appoint a committee to prepare arguments advocating voters' rejection of the measure.

At the July 16, 2014 meeting, the Government Performance and Finance Committee recommended the appointment of the individuals listed above to the For and Against Committees for proposed amendments to the Tacoma City Charter.

ISSUE:

Members must be appointed to serve on For and Against Committees for proposed amendments to the Tacoma City Charter.

ALTERNATIVES:

If Council does not adopt the resolution, the City will not comply with RCW 29A.32.280.

RECOMMENDATION:

Staff requests the City Council appoint members to serve on For and Against Committees for proposed amendments to the Tacoma City Charter.
