At approximately 10:05 a.m., Chris Bell, Management Fellow, Office of Management and Budget, presented the 2017 annual Government

Performance and Finance Committee report. He reported on the updates of financial policies, process improvements, intergovernmental relations, requests for actions, and comparisons between the 2016 and 2017 annual reports.

Eliminating Certain Authority Related to the Granting of Severance Payments [Bill Fosbre, City Attorney, City Attorney Office and Gary Buchanan, Director, Human Resources]

At approximately 10:07 a.m., City Attorney Bill Fosbre introduced Karen Short, Human Resources Analyst, and provided background summary of Ordinance No. 27636 relating to the authority of the granting of severance payments, and incidents since 2007 where individuals have been provided an employment agreement authorizing the payment of severance benefits. Mr. Fosbre reviewed on the difference between non-represented and represented employees, terms involved of the employment agreement, current authorities, restrictions if applicable, an overview of compensation codes, what the language would look like if these agreements were eliminated, and the approval process. Ms. Short provided background of the 2007 legislation involving recruitment and retainment of the agreements, the usage of this legislation, and a continued overview of the severance benefits.

Discussion ensued throughout regarding the terms involved, intent and uses, concern regarding abuse of the agreement, clarification on background summary, how agreements could be drafted, employee choices of severance benefits, the fiscal impact and overall impact on the future, language defining without cause needs or with cause needs, the removal of the appointment, and clarification on severance clause. Discussion continued regarding the establishment of common language, revisions to accommodate different departments, consistency of language, unexpected consequences, and the recommended language.

There was no public comment.


## Adjournment
