1 BY REQUEST OF COUNCIL MEMBERS BLOCKER, CAMPBELL AND  
2 LONERGAN

3 A RESOLUTION relating to committees, boards, and commissions; appointing  
4 and reappointing individuals to the Human Rights Commission.

5 WHEREAS vacancies exist on the Human Rights Commission, and

6 WHEREAS, at its meeting of March 23, 2017, the Community Vitality and  
7 Safety Committee conducted interviews and recommended the appointment and  
8 reappointment of individuals to said commission, and

9 WHEREAS Ordinance No. 18301, passed May 31, 1967, provided that  
10 initial terms for commission members would be one, two, or three years to  
11 ensure a rotation of members with staggered terms, and

13 WHEREAS, over time, terms have become aligned, such that terms have  
14 varying expiration months in March, April, May, and December, and more than  
15 one-half of commission member terms will expire in 2019, and

17 WHEREAS it is necessary to realign terms for ease of administration and  
18 to ensure a staggered rotation of commission members, and

19 WHEREAS, pursuant to the City Charter Section 2.4 and the Rules,  
20 Regulations, and Procedures of the City Council, the persons named on  
21 Exhibit "A" have been nominated to serve on the Human Rights Commission;
