Mr. Ziegler provided a copy of the WSDOT Puget Sound Gateway Funding and Phasing Study report of September 2013. A copy of the report is available upon request. It was agreed that there is widespread support for this project and that everyone should take advantage of any opportunity to promote it.

<u>Eastside Community Center</u> - Nancy Davis and Alisa O'Hanlon reported on a recent public meeting with eastside community members to gather input and suggestions on a proposed East Tacoma Community Center. The final feasibility study is expected to be complete by late January or early February and will be brought to the next meeting of JMAC. The report of the public meeting is available upon request.

Mental Health Services in and around Tacoma/Pierce County – Connie Brown, Allen Ratcliffe and Bob Winslow reported in depth on the status of mental health services in and around Tacoma and Pierce County as well as the Pierce County Human Services Coalition Legislative Priorities for 2014. The committee agreed that much more conversation and information are needed and this topic will be on a future agenda with additional guest speakers.
