#### 3. Staffing Update

- Vicky has stepped in as program manager for Social Wellness in Shelley's absence per the new restructuring within the department
- Nhan Nguyen, program manager for Homelessness and Household Stability (HHS)
  - Genesis Gavino has begun as a Systems Analyst within HHS
- HHS is now fully staffed and the other two areas will be staffed between now and the next biennium

### 4. Human Services Division - New Business Model Update a. Timeline for upcoming Process

• Applications accepted from providers from: July 15<sup>th</sup> through August 15<sup>th</sup>

• Training on the rating tool is being developed by Jaime and will be run by the HSC as a test drive

#### b. Systems Training Info and Dates

- Heavy investment in systems work and encouraging providers to partner and leverage their strengths
- There will also be an application process for single applicants as well, who may not be partnering with other organizations but will provide a value add in their category
- A consultant, Fay Hanley Brown was brought in for two trainings with City of Tacoma staff (Jovan, Korey, Al, and Rahn were able to attend both or one of the trainings). Other funders were invited to the training (United Way attended) in order for funders to understand the new shift from the City and have a shared framework.
- The goal was to educate city of Tacoma staff first, and now there will be a 101, 201, and 301 trainings for providers.

- 101 & 201 are mandatory for everyone who is currently funded and for anyone who is planning to apply in the upcoming process
- 301 is strongly encouraged for everyone.
   An invitation to HSC members will be extended for those who'd like to attend for all three sessions.
- What is understood and recognized is that this shift is going to be significant and will be a journey for both the city and the providers.
- Providers were only given 2 ½ business days to respond, but that deadline was
  extended if providers were unable to respond. There was information shared with
  providers over the last couple of months over two meetings where attendance was
  packed and there were good questions and good feedback. A notice will go out inviting
  anyone who has not responded to reply if they are able to attend.

#### c. Equity and Inclusion

Equity is infused throughout this process.

#### d. Expectations for "Buckets"

Analyzed all of existing contracts to identify which "bucket" of the three foci (Homelessness & Household Stability, Social Wellness, and Opportunity & Achievement) they fall into. That analysis allowed the City to identify where the money is currently delineated. The lion's share of funding fell into the Homelessness and Household Stability. Other providers in the other "buckets" will have extended contracts provided their performance is meeting expectations.
