RECOMMENDATION SUMMARY:

Tacoma Fire Department (TFD) recommends a contract be awarded to Stryker Sales LLC, Kalamazoo, MI, in the amount of \$6,793,754, plus applicable taxes, plus a 10 percent contingency to allow for additional equipment, budgeted from the TFD Emergency Medical Services Fund, for a contract term of 10 years, for lease and maintenance of emergency medical equipment to include nineteen heart monitors/defibrillators, seventy seven automated external defibrillators (AEDs), and twenty cots/load systems, and fifteen stair chairs.

STRATEGIC POLICY PRIORITY:

- Strengthen and support a safe city with healthy residents.
- Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

Emergency medical equipment is critical to providing immediate patient care to the City of Tacoma, City of Fircrest, and Pierce County Fire District 10 that are covered by Tacoma Fire Department through a service contract. Properly functioning equipment provides better patient outcomes for a healthy community, and the recommended lease contract provides consistent pricing for a 10-year period to limit budgetary fluctuations on some of our most crucial and costly assets.

BACKGROUND:

TFD's first responding, patient transport, and support units have emergency medical equipment for on-scene patient care. This equipment includes heart monitors/defibrillators and AEDs for cardiac patients and incidents, cots/load systems for patient transport units, and stair chairs to move patients downstairs without lifting. Of the one hundred plus emergency medical equipment items owned by TFD, seventy percent are past their useful life and need replacement; all are currently from Stryker-owned brands.

Rather than purchasing the assets, TFD recommends awarding a contract to Stryker Corporation for the ALS 360 lease program, which provides level payments for 10 years, includes two rounds of equipment refresh – one at the start of the contract and the second at or before the five-year mark – and all preventative maintenance and service on equipment. All currently owned equipment would be returned to Stryker for a trade-in credit (included in recommended contract amount).

ISSUE: Seventy percent of TFD's emergency medical equipment assets are past their useful life and in need of replacement.

ALTERNATIVES: TFD could choose traditional procurement and own all assets and would be subject to market price increases over the 10-year period, as well as fluctuating budget requests for one-time capital asset investments. Any procurement could be delayed however with seventy percent of our emergency medical equipment being past useful life, our maintenance costs are increasing, some of our equipment is damaged and close to no longer being supported by Stryker for software updates.

COMPETITIVE SOLICITATION:

Quotes were solicited using the Savvik Buying Group, competitively bid through Request for Bids Specification No. PSAI RFB 2021-06. Thirty-three companies were invited to bid in addition to normal advertising of the project. Eight submittals were received. Through an interlocal cooperative purchasing agreement, the City will purchase the needed equipment at the prices, terms and conditions of this contract. The ability to participate in cooperative purchasing through national contracts provide the City increased savings by pooling resources to leverage the market through volume discounts. Eight vendors were awarded contracts with Savvik Buying Group after evaluation based on weighted factors including:

- General Requirements (40%)
- Technical Requirements (20%)
- Pricing (40%)

Stryker Sales, LLC submitted a bid that resulted in receiving one of the awarded contracts.
