– June 3, 2025
DATE: May 12, 2025

SUMMARY AND PURPOSE:

An ordinance adopting the draft Six-Year Comprehensive Transportation Improvement Program Amended 2025 and 2026-2031.

BACKGROUND: This Department’s recommendation is based on Section 35.77.010 of the Revised Code of Washington (RCW) that provides that the legislative body of each city and town prepare and adopt a comprehensive transportation program for the ensuing six calendar years and annually thereafter pursuant to one or more public hearings, prepare and adopt a revised and extended comprehensive transportation program, and each one-year extension and revision thereof will be filed with the Secretary of Transportation of the State of Washington. Section 35.77.010 of the RCW further provides that each city will include in their comprehensive transportation program how they intend to expend the revenues for non-motorized transportation purposes.

The City adopted the Transportation Master Plan in December 2015, which includes a prioritized list of transportation projects. The adoption of the Transportation Master Plan included extensive citywide community outreach, including attendance at neighborhood festivals and clean-ups, and two public hearings. The proposed list of projects to be added to the draft Six-Year Comprehensive Transportation Improvement Program supports the goals and policies, as well as network priorities outlined in the Transportation Master Plan.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

To date in 2025, staff provided presentations to the Infrastructure, Planning, and Sustainability Committee on the Six-Year Comprehensive Transportation Improvement Program amendment process and timeline on February 26, 2025, and the full draft Six-Year Comprehensive Transportation Improvement Program Amended 2025 and 2026-2031 on April 23, 2025. Staff also provided a presentation to the Transportation Commission on the Six-Year Comprehensive Transportation Improvement Program amendment process, timeline, and the proposed list of projects to be added to or removed from the draft Program on April 16, 2025. A presentation was also provided to the City Council at the May 6, 2025 Study Session. A public hearing is scheduled to be held on Tuesday, May 20, 2025, at approximately 5:15 p.m., at the City Council meeting.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

This ordinance provides the City with an opportunity to implement the Transportation Master Plan that prioritizes mobility for all modes, ages, and abilities with active transportation as the priority.

Livability: Equity Index Score: High Opportunity

Improve access and proximity by residents to diverse income levels and race/ethnicity to community facilities, services, infrastructure, and employment.

Decrease the percentage of individuals who are spending more than 45% of income on housing and transportation costs.



Explain how your legislation will affect the selected indicator(s).

The draft Six-Year Comprehensive Transportation Improvement Program Amended 2025 and 2026-2031 was developed in concert with the Transportation Master Plan vision that Tacoma is a sustainable community with many drivers, residents, businesses, and visitors who have various transportation priorities. The City is strategic in how it plans its transportation system with an emphasis on carrying the people and goods that foster Tacoma's culture, character, and competitiveness. The transportation system offers multimodal travel options that provide safe access for all users and neighborhoods that encourage healthy living and protect the environment. The projects and programs included in the draft Six-Year Comprehensive Transportation Improvement Program Amended 2025 and 2026-2031 focus on being a partner, protecting the community, providing mobility for all, striving for fiscal, environmental, and social sustainability, leveraging programs and services, and linking to land use.

Delaying the adoption of the draft Six-Year Comprehensive Transportation Improvement Program Amended 2025 and 2026-2031 may result in the loss or delay of State and Federal grant funding, and project delivery.

EVALUATION AND FOLLOW UP:

The status of projects funded and infrastructure improvements completed are tracked through the Streets Initiative Annual Report and annual Six-Year Comprehensive Transportation Improvement Program amendments. This can be compared to the same data collected each year so that changes overtime can be observed, and future Six-Year Comprehensive Transportation Improvement Programs can be updated.

STAFF/SPONSOR RECOMMENDATION:

The Public Works Department recommends City Council adopt the draft Six-Year Comprehensive Transportation Improvement Program Amended 2025 and 2026-2031.
