Clarissa Gines also mentioned that their partner Communities Rise is unable to provide application support this year, but that staff will be holding "drop-in conversations" to offer more accessible support for interested applicants.

Lisa Jaret then shared an update on Tacoma Creates' role as a community partner in the Beyond the Bell / Club B work, and announced a name change, going from "Office of Arts & Cultural Vitality" to "Arts & Cultural Vitality Division".
