South Sound Biotech Proof of Concept Center & Academy (Pat Beard, Project Manager, Community and Economic Development)

At approximately 10:03 a.m., Pat Beard, Community and Economic Development, Colonel David McCune, Madigan Army Medical Center, Dr. Paul Amoroso, Multicare Institute for Reasearch and Innovation, and Rob Arnold, University of Washington, provided an overview of the South Sound Biotech Proof of Concept Center and Academy, including background information, Federal i6 Challenge Grant, roles of the core partners, issues, alternatives, fiscal impact and concluded by requesting a

recommendation to move forward to the full City Council for consideration.
