## **SUMMARY AND PURPOSE:**

An ordinance amending various chapters in Tacoma Municipal Code Subtitle 6B to:

1) increase the minimum threshold before an out-of-city business is required to be licensed;

2) increase regulatory license fees effective August 1, 2025 to cover cost of review, inspection and administration of the license;

3) change the title of the Home Occupation license to Residential Business license consistent with Title 13; and

4) clean-up and clarify language throughout the subtitle.

## **BACKGROUND:**

The Finance Department's Tax & License Division recommendation is based on the City's requirement to comply with the State Business License Model Ordinance. Additionally, after a review of Subtitle 6B there are recommended updates to license fees and clean-up of language throughout the subtitle.

The Government Performance and Finance Committee voted unanimously on June 3, 2025, to move this proposal forward to the full City Council.

## **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

This Ordinance primarily clarifies and corrects code language where appropriate which does not directly affect any business owners or taxpayers. The increase to the minimum threshold for out-of-state businesses provides relief to businesses located outside of the City who sell minimal services or products in the city.

## **2025 STRATEGIC PRIORITIES:**

#### Equity and Accessibility: (Mandatory)

Review of the Tax & License code on regular intervals allows staff to use equity and bias training to review the code through an equity lens. While many sections pertain to requirements on businesses and administrative functions, reviewing these through an equity lens allows for removal or changes to code language that would impact the City's equity and anti-racist efforts.

**Economy/Workforce:** *Equity Index Score*: Moderate Opportunity Increase positive public perception related to the Tacoma economy.

Livability: Equity Index Score: Moderate Opportunity

Increase positive public perception of safety and overall quality of life.

2) increase regulatory license fees effective August 1, 2025 to cover cost of review, inspection and administration of the license;

3) change the title of the Home Occupation license to Residential Business license consistent with Title 13; and4) clean-up and clarify language throughout the subtitle.
