SUMMARY AND PURPOSE:

A resolution authorizing the execution of a Letter of Agreement as negotiated with the Tacoma Firefighters Union, Local 31, regarding a new classification to be titled Fire Marshal.

BACKGROUND:

The resolution will authorize the execution of a Letter of Agreement (LOA) as negotiated with the Tacoma Firefighters Union, Local 31 regarding a new classification to be titled Fire Marshal.

The City and Local 31, have reached an agreement regarding a new classification of Fire Marshal (CSC 40170). The Fire Marshal classification will be classified, salaried, exempt from overtime, and represented by the Tacoma Firefighters Union, Local 31. Selection for this position for Prevention will be pursuant to terms outlined in Appendix A, Applications of Rate, Section F, of the Collective Bargaining Agreement.
