DATE: December 10, 2024

SUMMARY AND PURPOSE:

The proposed ordinance would amend Chapter 1.06 of the Tacoma Municipal Code relating to collections and claims to update the procedures and authority for filing and resolution of claims against the City and claims the City may have against third parties.

BACKGROUND:

The City's claims and collections procedures are found at TMC 1.06.226 (Cancellation of Amounts Due), TMC 1.06.228 (Claims Against the City), TMC 1.06.229 (Claims - Settlement), TMC 1.06.230 (Claims - Release) and TMC 1.06.231 (Claims - Prosecution). The City Attorney's Office and Department of Finance recommend that the claims and collections procedures be updated and consolidated.

The proposed changes would, (1) consolidate within TMC 1.06.226 the above-referenced claims, collection and settlement procedures, (2) clarify the authority of the Finance Director to collect and settle amounts due to the City that arise from any judgment, lawful debt owed or from a claim by the City against another person either arising in contract, law, tort or in equity, (3) increase the dollar amount of claims that may be resolved administratively, i.e., without prior City Council approval, (4) clarify the type of claims that may be prosecuted by the City Attorney on behalf of the City, and, (5) align the claims filing procedures with state law.

If approved, the proposed changes would (a) create a centralized and better organized format for claims and collections procedures, (b) expand administrative claims settlement authority, (c) increase the dollar amount of claims that may be settled administratively, (d) increase the Finance Director's settlement and write-off authority for amounts due to the City, and (e) align the claims filing procedures with state law. These changes would, align the code with current risk management practices and experiences and with the statutory claim filing requirements, create a more user-friendly format, and provide flexibility to expedite the claims settlement process to, when appropriate, resolve claims more quickly and reduce litigation expenses.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

The City Attorney's Office has heard from the community that the claim filing, review and decision-making process takes too long. The proposed amendments are intended to create more flexibility to allow for more timely payment of claims that are appropriate for settlement by the City. Staff have also reviewed claims procedures in other jurisdictions to identify best practices.



2025 STRATEGIC PRIORITIES:

Equity and Accessibility: (Mandatory)

The proposed ordinance will create greater flexibility and opportunities to settle claims in a manner that reduces litigation expenses and the fiscal impact of each settlement as a means to reduce impacts to the general fund allowing the savings to be allocated to City priorities.

Civic Engagement: Equity Index Score: Moderate Opportunity

Increase the percentage of residents who believe they are able to have a positive impact on the community and express trust in the public institutions in Tacoma.

STAFF/SPONSOR RECOMMENDATION:

The City Attorney’s Office and Department of Finance recommend that the claims and collections procedures codified at TMC Chapter 1.06 be updated for clarity and efficiency, to create a centralized and better organized format for claims and collections procedures, to increase administrative settlement authority in alignment with current experiences and risk management , to increase the dollar amount that claims may be settled administratively to expedite the claims settlement process to, when appropriate, resolve claims more quickly and to minimize litigation expenses; to increase the Finance Director’s settlement and write-off authority for amounts due to the City to align with current risk management practices and, to align the claims filing procedures with state law.
