



RESOLUTION NO. 40643

1 A RESOLUTION setting Tuesday, September 29, 2020, no earlier than 5:15
2 p.m., as the date for a public hearing upon completion of Regular Agenda
3 items, on the potential reauthorization and extension of the Tideflats
4 Interim Regulations, as adopted by the City Council on November 21,
5 2017, by Amended Ordinance No. 28470, and as previously extended by
6 Ordinance Nos. 28542, 28583, 28619 and 28671.

7 WHEREAS on May 9, 2017, the City Council adopted Amended
8 Resolution No. 39723, initiating a subarea planning process for the Port of
9 Tacoma/Tideflats ("Tideflats") area, which additionally requested the Planning
10 Commission ("Commission") to consider the need for interim regulations in the
11 Tideflats area while the subarea planning process is under way, and

12 WHEREAS the Commission determined the interim regulations were
13 warranted, and forwarded its recommendation to the City Council for
14 consideration on October 4, 2017, and

15 WHEREAS in support of these deliberations, the Commission conducted a
16 public hearing at which 81 people testified, and reviewed over 200 written
17 comments, and

18 WHEREAS, following its own public hearing with substantial community
19 input and deliberation, the City Council adopted the interim regulations on
20 November 21, 2017, by Amended Ordinance No. 28470, which includes the
21 following elements:

- 23 • Category 1: Expanded public notification of heavy industrial use

- Category 2: Temporary prohibition of new non-industrial uses in the Port of Tacoma Manufacturing and Industrial Center;
- Category 3: Temporary prohibition of new residential development along Marine View Drive and northeast Tacoma slopes; and
- Category 4: Temporary prohibition on certain types of new heavy industrial uses.

WHEREAS following another public hearing, which included substantial community input and deliberation, the City Council passed Ordinance No. 28542 on November 13, 2018, which extended the interim regulations for another six months, and

WHEREAS following another public hearing, which included substantial community input and deliberation, the City Council passed Ordinance No. 28583 on May 21, 2019, which extended the interim regulations for another six months, and

WHEREAS following another public hearing, which included substantial community input and deliberation, the City Council passed Ordinance No. 28619 on November 12, 2019, which extended the interim regulations for another six months, and

WHEREAS following another public hearing, which included substantial community input and deliberation, the City Council passed Ordinance No. 28671 on May 19, 2020, which extended the interim regulations for another six months, with a current expiration date of December 2, 2020; Now, Therefore,
