At approximately 4:57 p.m., Erik Sloan, Pavement Manager, PW, presented the Tacoma Streets Initiative progress report, including an overview; background, noting Proposition 3, Transportation Benefit District Proposition A, and funding; recent challenges; 2019-2020 revenues and expenditures; street maintenance; capital projects; and active transportation projects.

Discussion ensued regarding funding for various projects, project timelines, information available to the public, utilizing the Streets Initiative dashboard website, using the Equity Index to apply projects around the City, sidewalks near transit stops, future public outreach, and considerations for future funding and initiatives.
