RECOMMENDATION SUMMARY: Tacoma Venues and Events (TVE) recommends a contract be awarded to Premium Parking Service LLC, (Premium Parking), New Orleans, LA, in the amount of \$2,000,000, plus applicable taxes, budgeted from Dome fund 4180, for an initial contract term of five years plus one additional two-year renewal option, for provisions of professional parking services for the Tacoma Dome (Dome).

STRATEGIC POLICY PRIORITY:

- Foster a vibrant and diverse economy with good jobs for all Tacoma residents.
- Cultivate a vibrant cultural sector that fosters a creative, cohesive community.

Dome parking operations are integral to its customer service delivery and financial success. As a key source of revenue, operations must be fiscally sound, sustainable, and customer-centric in support of creating a vibrant cultural sector in the community.

BACKGROUND: To attain optimal revenue and service goals, TVE requires an industry-specific and expert contractor with proven experience in parking operations. The contractor will provide ongoing professional parking services including daily operations, event operations, and enhanced customer service support for the users and clients of the Dome parking system.

ISSUE: The current contract for the Dome parking operation services is set to expire on June 30, 2025, requiring immediate action to ensure uninterrupted parking operations. Without a new contract in place before the expiration date, the Dome risks disruption to its parking services, potentially impacting venue operations and revenue generation.

ALTERNATIVES: There are limited viable alternatives to contracting these services. If the contract is not granted, it would cause significant disruption to the parking operation services at the Dome, as TVE does not currently have the necessary workforce, technology infrastructure, or specialized expertise to perform this function effectively.

COMPETITIVE SOLICITATION: Request for Proposals Specification No. PF24-0089F was opened August 20, 2024. Twenty companies were invited to bid in addition to normal advertising of the project. Five submittals were received. Premium Parking ranked first out of the five submittals. The table below lists the respondents along with their rank.
