  Resolution adopting a policy to ensure the rights and dignity of all residents are maintained
  and protected.
- 3. **Council Member Diaz** provides the attached **Council Action Memorandum** for a Resolution affirming the City of Tacoma's commitment to our LGBTQIA2S+ community so they can live authentically and without fear of discrimination or harm.
- 4. Shiloh Baptist Church Men's Shelter Standdown: The single men's shelter (1211 South I Street), operated by Shiloh Baptist Church (Shiloh) and Valeo Vocation (Valeo), is currently preparing to standdown. Valeo will continue to work with the current residents on their stability and housing plans and anticipates all residents will transition into permanent housing or other temporary solutions by March 31, 2025. After this date, Shiloh will continue to focus on providing housing services with their New Life housing program. Since opening in September 2021, the shelter has served 317 individuals, with 21 of the clients being connected to permanent housing.

As of February 18, 2025, there were 21 residents at the site and seven residents are currently working with case management. Neighborhood and Community Services has begun meeting with Shiloh and Valeo weekly to assess operational needs and will continue to support the shelter during this transition. The City is committed to ensuring that every resident has the option to transition to the new location or has an alternative shelter location should they wish on or before March 31, 2025.

Encampment Outreach: For the week of February 10 14, 2025, the City's Homeless Engagement and Alternatives Liaison (HEAL) contacted 51 individuals (35 new and 16 repeat) and referred them to community services; 13 individuals were placed in shelter. The Dashboard incorrectly states that staff visited 19 locations and contacted 5 individuals. Staff is working to correct the dashboard. #### **SUMMARY AND PURPOSE:**

A resolution directing the City Manager to use no City funds, facilities, property, equipment, or personnel to investigate, enforce, cooperate with, or assist in the investigation or enforcement of any federal registration or surveillance programs or any other laws, rules, or policies that target individuals in Tacoma solely on the basis of race, religion, immigration, or citizenship status, or national or ethnic origin. This does not prohibit the collection, use, or disclosure of information that is required to comply with state or federal law, or in response to a lawfully issued court order.

#### **BACKGROUND:**

#### The Sponsors' Recommendation is Based On:

This resolution directs the City of Tacoma to mimic Washington State Law (RCW 43.17.425) which says no state agency, including law enforcement, may use agency funds, facilities, property, equipment, or personnel to investigate, enforce, cooperate with, or assist in the investigation or enforcement of any federal registration or surveillance programs or any other laws, rules, or policies that target Washington residents solely on the basis of race, religion, immigration, or citizenship status, or national or ethnic origin. Like in the state law, this does not prohibit the collection, use, or disclosure of information that is required to comply with state or federal law, or in response to a lawfully issued court order.

According to the Washington State Budget & Policy Center, immigrants make up fifteen percent of Washington's population and nineteen percent of Washington's labor force, and are responsible for twenty one percent of the state's Gross Domestic Product (GDP). The state Legislature found in 2019 that fifteen percent of all business owners in the state of Washington were born outside the country and that these business owners have a large impact on the economy through innovation and the creation of jobs, and make a significant contribution to the economic vitality, prosperity and strength of the state.

The City of Tacoma has a proud history of inclusivity, tolerance, and compassion for all residents. The diversity of our people and cultures is a critical part of who we are as a City. Everyone has the right to live peacefully and without fear, and we condemn the persecution of many others around the world who face extreme barriers and inequitable treatment on account of their race, ethnicity, education level, economic status, gender, immigration status, sexual orientation, skin color, religion, political opinion, and other identities.

Tacoma is a welcoming City that affirms the fundamental dignity of immigrants and refugees, commits to building welcoming communities, and brings together community members in a spirit of solidarity. As of 2022 over 12 percent of Tacoma's population was born outside the United States, and nearly 20 percent speak a language other than English at home. The inclusivity of our immigrant and refugee community members aligns with the City's Equity and Empowerment framework, which strives to give everyone equitable access to the opportunities necessary to assert their human rights, satisfy their essential needs, advance their well-being, and achieve their full potential.

Currently, Washington state law (RCW 10.93.160) states local law enforcement may not: inquire into or collect information about an individual's immigration or citizenship status, or place of birth unless there is a connection between such information and an investigation into a violation of state or local criminal law; or provide information pursuant to notification requests from federal immigration authorities for the purposes of civil immigration enforcement, except as required by law.

#### **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

Sponsors met with a broad range of stakeholders to discuss and request feedback on this policy, including the Commission for Immigrant and Refugee Affairs, the Tacoma Healing Awareness Committee, the Tacoma Refugee Choir, One America, Advocates for Immigrants in Detention Northwest (AIDNW), Golden Bamboo Walking Group, the Eastside Neighborhood Advisory Council of Tacoma, the South End Neighborhood Council, and other local elected leaders.

#### **2025 STRATEGIC PRIORITIES:**

#### Equity and Accessibility: (Mandatory)

Approximately 7% of the US population, or 22.8 million people, are non-citizens. In 2017, nearly 260,000 people sought asylum, or protection from persecution, within the United States. As of 2022, over 12 percent of Tacoma's population was born outside the United States, and nearly 20 percent speak a language other than English at home. Today, immigrant communities are under threat of mass deportations. Anyone without secure immigration status may be subject to enforcement efforts. People who were ordered deported in the past and people who have had contact with the criminal legal system are at particular risk. These immigrant populations experience unique risks to health, including pre-migratory trauma, unsafe and stressful migration experiences, and post-migration discrimination. Human rights abuses can occur across this spectrum of the immigrant experience. In addition, these health behaviors and outcomes ripple throughout the communities to which immigrants belong.

**Economy/Workforce:** *Equity Index Score*: Moderate Opportunity Increase positive public perception related to the Tacoma economy.

**Education:** *Equity Index Score*: Moderate Opportunity

All students will graduate from high school and be prepared to enter the workforce or pursue post-secondary education.

**Civic Engagement:** *Equity Index Score*: Moderate Opportunity

Increase the number of residents who participate civically through volunteering and voting.

Increase the percentage of residents who believe they are able to have a positive impact on the community and express trust in the public institutions in Tacoma.

Representation at public meetings will reflect the diversity of the Tacoma community

Improve access and proximity by residents to diverse income levels and race/ethnicity to community facilities, services, infrastructure, and employment.

Improve health outcomes and reduce disparities, in alignment with the community health needs assessment and CHIP, for all Tacoma residents

Explain how your legislation will affect the selected indicator(s)?

Every person has fundamental human rights. Targeting people solely on the basis of race, religion, immigration, or citizenship status, or national or ethnic origin is discriminatory action that harms our community. Efforts to strip civil rights from a portion of our community are designed to create fear and push communities into hiding and outside the social structure that holds our community together. By making clear the City will not participate in these actions, we build trust with community and create a more welcoming environment.

#### **SUMMARY AND PURPOSE:**

A resolution to affirm and reaffirming the City of Tacoma's commitment to ensuring that all individuals, regardless of sexual orientation or gender identity, feel safe and supported; its commitment to diversity, inclusion, and justice, ensuring that all members of our community can live authentically and without fear of discrimination or harm; and to protecting the civil rights of our LGBTQIA2S+ community.

#### **COUNCIL SPONSORS:**

Council Members Diaz, Hines, and Rumbaugh.

#### **BACKGROUND:**

#### This Department's Recommendation is Based On:

The City of Tacoma is committed to fostering a community where all individuals are treated with dignity, equity, and respect, regardless of sexual orientation, gender identity, or gender expression. LGBTQIA2S+ individuals face ongoing discrimination, violence, and systemic barriers that threaten their safety, well-being, and human rights. Transgender and non-binary people in particular have been vilified in political advertisements and Project 2025 outlines further plans to remove established rights and criminalize the existence of transgender people. There have been several executive orders in recent weeks targeting the LGBTQIA2S+ community, particularly targeting transgender youth. Across the country there continues to be legislation enacted that targets LGBTQIA2S+ communities, threatening access to healthcare, education, and protections under the law. The City of Tacoma recognizes the inherent worth and equal rights of all people, including LGBTQIA2S+ individuals, and seeks to provide a safe and welcoming environment for those who reside in or visit our city. Tacoma commits to protecting and advocating for the rights of LGBTQIA2S+ individuals by rejecting policies and actions that promote discrimination, harm, or inequality, and embraces and supports Washington's Law Against Discrimination, Chapter 49.60 RCW, and Ordinance 28858, which adopted Chapter 9A.50 RCW into Tacoma's "Public Safety" code to authorize the City Attorney to prosecute violations as a gross misdemeanor in Tacoma Municipal Court should someone encroach on individuals' right to access a health care facility to seek gender affirming care.

This resolution declares that the City of Tacoma strongly believes in and affirms the right of individuals to:

- a. Seek, obtain, provide, or facilitate gender-affirming care, especially for youth, in accordance to state laws;
- b. Have access to facilities which may require the use of gender-segregated facilities, such as restrooms, locker rooms, dressing rooms, and homeless or emergency shelters, that are consistent with that individual's gender expression or gender identity;
- b. Engage in speech or expression supporting LGBTQIA2S+ people; including but not limited to disseminating books and literature, engaging in the arts, holding discussions, and drag or other cultural performances;
- c. Embrace and express their own authentic gender and sexuality and to define what gender and family means to them; including but not limited to dress and appearance, structuring a family unit that works best for them, and sharing LGBTQIA2S+ positive values with their children; and
- d. Define their own gender and sex with or without regard to biological sex assigned at birth.

This resolution further directs:

No City of Tacoma resources, including, but not limited to, City property or time spent while on duty by a covered employee, shall be used for investigation, assisting an investigation, arrest, or prosecution of an individual on the basis of exercising their rights identified above. In the event any law or regulation is passed in the State of Washington which imposes criminal punishment, civil liability, administrative penalties, or professional sanctions, on an individual or organization exercising their rights, the City Manager shall make enforcement of said law or regulation among the City's lowest enforcement priority.

Whenever the City collects information about an individual or individual's sex or gender, it will not request gender assigned at birth. The City will not seek to collect or disseminate information about sex assigned at birth, unless related to a criminal investigation of a violation of Washington State law. The City will actively oppose legislation or actions at the state or federal level that threaten the rights, safety, or dignity of LGBTQIA2S+ individuals.

The City commits to ongoing engagement and collaboration with local LGBTQIA2S+ community and cultural leaders to build understanding and awareness of needs specific to the LGBTQIA2S+ community, so the City can adapt to meeting community-specific safety needs to engender feelings of safety at gatherings and public events. The City commits that our police department will continue efforts to build trust with all people in Tacoma, including our LGBTQIA2S+ community, and will actively investigate hate crimes, which includes crimes targeting individuals due to their actual or perceived gender or sexual orientation.

The City shall apply an equity analysis to all newly created policies to ensure they are inclusive, equitable, and affirming for LGBTQIA2S+ individuals. The administration of these policies should be done equitably and without violating individual civil rights.

The City of Tacoma will continue to celebrate and uplift the voices and contributions of LGBTQIA2S+ individuals through public events, education, and partnerships with local organizations.

#### **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

Council Member Diaz heard from prominent LGBTQIA2S+ community leaders requesting the Council take this action, including outreach to the Oasis Youth Center and other elected leaders.

#### **2025 STRATEGIC PRIORITIES:**

#### **Equity and Accessibility:**

The City of Tacoma is proud to be home to a LGBTQIA2S+ community. According to the Census Pulse survey data averaged between July 2021 and May 2023, about 516,000 (17%) adults identify as LGBTQ+ in the Seattle-Tacoma-Bellevue, WA Metropolitan Statistical Area.1 Even with committed public leaders and legal protections, LGBTQIA2S+ people experience structural and interpersonal discrimination that adversely affects their well-being and drives disparate outcomes across crucial areas of life. These desperate impacts increase when LGBTQIA2S+ individuals face intersecting forms of discrimination, such as sexism, racism, and ableism, all at the same time. Transgender and non-binary people in particular have been vilified in political advertisements and Project 2025 outlines further plans to remove established rights and criminalize the existence







**DATE:** February 12, 2025

I ask for your support for a Resolution expressing support for the passage of Proposition No. 1 submitted by the City of Tacoma on the April 22, 2025, Special Election ballot, to fund street repair, maintenance, and safety improvements for streets, including bicycle and pedestrian improvements; and encouraging residents to vote "Approved" on Proposition No. 1 on the April 22, 2025, Special Election ballot.

#### **LEGISLATIVE INTENT:**

#### **Resolution/Ordinance Request:**

At its meeting of December 17, 2024, the Tacoma City Council unanimously adopted Resolution No. 41588 authorizing the submission to voters, at an election to be held on April 22, 2025, of a proposition to continue an increased funding level for street repair, maintenance, and safety improvements for streets, including bicycle and pedestrian improvements, by levying an additional 2% utility tax on natural gas, electric, and phone utilities effective 2026; increasing the regular property tax levy by \$0.25/\$1,000 of assessed value for a maximum levy rate of \$1.95/\$1,000 of assessed value for collection in 2026; authorizing the 2026 levy amount as the basis to calculate future levies per RCW 84.55. Qualifying seniors and others are exempt per RCW 84.36.381.

In 2015, Tacoma voters passed Propositions No. 3 and A, which set the foundation for the Tacoma Streets Initiative. Proposition No. 3 increased taxes by 1.5% on natural gas, electric, phone companies and property taxes by \$0.20/\$1,000 of assessed value. Proposition A raised the sales tax by one-tenth of one percent. Over the past decade, this initiative has allowed the Public Works Department to complete over \$397 million in critical infrastructure improvements in the City's rights-of-way. As the current funding nears expiration in December 2025, the City Council submitted Tacoma Streets Initiative II to the Auditor's Office for inclusion on the April 2025 ballot.

Tacoma Streets Initiative II is expected to raise \$375 million for street repair, maintenance, and safety improvements for Tacoma streets, including pedestrian and bicycle improvements through an increase in property tax and utility tax. With grant match and additional partnerships, staff anticipates bringing in over \$900 million dollars over the first 15 years. The City will be able to improve 1,100-1,400 arterial lane miles, 250-300 sidewalk miles, 130-170 miles of bike infrastructure, maintain 5,200-6,200 residential blocks, to reduce wear and tear on residents' vehicles and keep freight, cars, and transit moving efficiently over a 15-year performance period, prioritizing accessibility, pedestrian safety, and multimodal connectivity.

RCW 42.17A.555, according to the state Public Disclosure Commission, allows elected boards, councils and commissions to "express a collective decision, or to actually vote upon a motion, proposal, resolution, order, or ordinance, or to support or oppose a ballot proposition so long as (a) any required notice of the meeting includes the title and number of the ballot proposition, and (b) members of the legislative body, members of the board, council, or commission of the special purpose district, or members of the public are afforded an approximately equal opportunity for the expression of an opposing view.

DESIRED RESOLUTION DATE: March 4, 2025

#### **COMMUNITY ENGAGEMENT/ (CUSTOMER RESEARCH):**

Public Works staff have been providing information on the Streets Initiative and plans for Proposition No. 1 through the City webpage and printed and digital materials. Staff have also been meeting regularly with community organizations, Neighborhood Councils, Business Districts, and partners as requested.

#### **2025 STRATEGIC PRIORITIES:**

#### **Equity and Accessibility:**

Investments will be made in historically underserved neighborhoods guided by the Tacoma Equity Index through capital projects and residential street improvements. Safety improvements and enhancements will also align with other plans like the City's Vision Zero plan.

#### **Economy/Workforce:** *Equity Index Score*: Moderate Opportunity

Increase the number of Tacoma households that have livable wage jobs within proximity to the city. Increase the number of infrastructure projects and improvements that support existing and new business developments.

**Education:** *Equity Index Score*: Moderate Opportunity

Demonstrate community support for education by increasing support for school levies and bonds; volunteering and mentoring youth.

#### **Civic Engagement:** *Equity Index Score*: Moderate Opportunity

Increase the number of residents who participate civically through volunteering and voting. Increase the percentage of residents who believe they are able to have a positive impact on the community and express trust in the public institutions in Tacoma.

**Livability:** *Equity Index Score*: Moderate Opportunity

Increase positive public perception of safety and overall quality of life.

Explain how your legislation will affect the selected indicator(s)?

This funding will support safety upgrades and infrastructure improvements necessary to ensure our roads continue to support the City's development. This legislation indicates support for the Proposition and will improve civic engagement by bringing more public support in front of the residents and giving them more reason to trust in the City. Additionally, the project itself creates more jobs close to home and ensures people view the City's Public Works Projects favorably. Additionally, investments will reduce congestion across Tacoma leading to saved time and fewer emissions; Expand safe networks for all, especially on Neighborhood Greenways, whether they walk, bike, use a wheelchair, take transit, or drive; and support workforce development, union jobs, and training focusing on sustainable career pathways for Tacoma and Pierce County.

I ask for your support for a resolution declaring it a priority to include at least one community member over the age of 65 on each of Tacoma's committees, boards, and commissions (CBC) when possible and directing the City Manager to keep the City Council informed on at least a quarterly basis about changes to senior representation on CBCs.

#### LEGISLATIVE INTENT

**Resolution Request:** Tacoma is committed to being an inclusive city that seeks to provide a healthy, vibrant, and equitable future for all.<sup>1</sup> To help achieve this goal, we have invested a great deal in ensuring that our young people have a voice in shaping our city. Yet, as Tacoma's aging population continues to expand, it is equally vital that our older community members also have a meaningful role in developing our policies and community investments.<sup>2</sup> By fostering greater engagement with those over the age of 65, we can make additional progress ensuring that our policies navigate challenges across the age spectrum and that Tacoma is a city for everyone.

Tacoma's volunteer committees, boards, and commissions (CBCs) provide a unique opportunity for community members to impact our city's future. Tacoma has more than a dozen CBCs that work on a wide range of topics, from urban design to human services.<sup>3</sup> Each CBC is unique in its purpose, mission, and role, but all help gather information, provide advice and recommendations, and aid the City Council in its decision-making.<sup>4</sup> While we have a designated Youth Commission, which is composed of middle or high school students and is responsible for bringing a youth-lens to city policies, we do not currently require our CBCs to have a designated seat for a community member over the age of 65. In fact, more than half of our current CBCs do not have a single senior member.

Not all seniors have the time, ability, or interest to serve in volunteer positions, but older community members often have a wealth of knowledge and professional experience that would add value to the discussions taking place in our CBCs. They also have unique needs and interests that younger CBC

members may not be attuned to in our community. Seniors can also help ensure that the improvements we make for younger generations are sustainable and equitable across all life stages.

The City Council is responsible for appointing all members of CBCs and this resolution would declare it a priority to include at least one community member who over the age of 65 years on each of Tacoma's CBCs when possible. It would also direct the City Manager to keep the City Council informed about changes to the number of seniors on our CBCs. This will help ensure that City Council Members keep the status of senior representation in mind when recruiting, interviewing, and appointing new CBC members.

DESIRED RESOLUTION DATE: March 4, 2025

#### **COMMUNITY ENGAGEMENT**

Community members raised concerns regarding the City's attention to senior issues with the City Council and City staff following changes to the City's senior services in late 2024. This engagement revealed a need to enhance the way senior interests and voices are included in the City Council's decision-making process. In December 2024, Council Member John Hines proposed enhancing senior participation and inclusion in the City's CBCs during a "Senior Summit" and received positive feedback from the community for this approach. The City's Age Friendly Action Plan, developed in 2021 with an advisory group of local experts and partners, also recommended that Tacoma take steps to highlight the needs of older residents and develop a more robust system of support for them.<sup>5</sup>

#### 2025 STRATEGIC PRIORITIES

**Equity and Accessibility:** Community members have expressed a strong desire to ensure that our aging population has a voice in discussions about the City's work and policies. By striving to include at least one older community member, our CBCs would reflect the diversity of our community and be better suited to navigate issues across the age spectrum. This will in turn help enable our CBCs to provide helpful and responsive input and expand the ability of our community members to have an impact on public institutions. Advancing this resolution will also help to ensure that Tacoma remains a city where all individuals, at every stage of life, feel connected and supported.

#### **Civic Engagement:** *Equity Index Score*: Moderate Opportunity

Increase the percentage of residents who believe they are able to have a positive impact on the community and express trust in the public institutions in Tacoma.

Increase the number of residents who participate civically through volunteering and voting. Elected officials, boards, commissions, and volunteer leadership will reflect the diversity of the Tacoma community.

**Livability:** *Equity Index Score*: Moderate Opportunity

Increase positive public perception of safety and overall quality of life.

#### **ALTERNATIVES**

Such a requirement may also lead to prolonged vacancies on some CBCs, as well as upend other preferred size and membership requirements.

#### **EVALUATIONS AND FOLLOW UP**

The City Manager would provide information on at least a quarterly basis to the City Council about the status of the inclusion of residents who are at least 65 years old on CBCs.

#### **SPONSOR RECOMMENDATION**

Sponsors recommend moving the resolution forward to a vote on March 4, 2025.

#### FISCAL IMPACT

There is no fiscal impact from this resolution beyond staff time to compile a list of all CBC members above the age of 65. City staff already collect information regarding age on the CBC application form.

- February 25, 2025

**DATE:** February 19, 2025

I ask for your support for a Resolution providing direction to the City Manager on where and when Commemorative Flags are flown at City of Tacoma facilities.

#### LEGISLATIVE INTENT:

This resolution provides direction to the City Manager on where and when Commemorative Flags should be flown at City of Tacoma Facilities. A "Commemorative Flag" is a flag that identifies with a specific event, cause, theme, or group of people that the City Council chooses to honor, recognize, or commemorate consistent with the City's official policies, priorities and sentiments. Commemorative Flag does not include advertising media, such as banners.

The current list of commemorative flags identified by the City Council to be raised, based on historical practice, is as follows:

- A Commemorative Pride Flag in support of the LGBTQIA2+ community, in celebration of PRIDE events, and as a statement to the public that discrimination, harassment and harm to LGBTQIA2+ individuals is not acceptable and will not be tolerated. The flag is typically flown for the month of July.
- The Trans Pride Commemorative Flag in support of the transgender community to recognize the Transgender Day of Visibility and the Transgender Day of Remembrance, in celebration of the lives and contributions of trans people, while also drawing attention to the public of the shared responsibility our community has to our trans friends, family, and neighbors, to continue to support them, help educate the public, fight for change, and eliminate hate-filled violence. The flag is typically flown for the days of March 31 and November 20.
- The Juneteenth Commemorative Flag in honor of the City, State and Federal Juneteenth holiday. Juneteenth is the oldest known celebration commemorating the ending of slavery in the United States. By raising the Juneteenth Flag and through other means, the City encourages employees and community members to learn more about this period in our history and commit to working for a society in which all people are truly free. The flag is typically flown for the day of June 19.
- An orange Commemorative Flag to raise awareness about gun violence prevention, and as a statement of our commitment to end senseless gun violence with evidence-based solutions, pledge to do all we can to keep firearms out of the wrong hands, and encourage responsible gun ownership to help keep our children safe and protect everyone in our community. The

flag is typically flown for Gun Violence Awareness Day and Wear Orange Weekend, which falls on the first Friday and weekend of June.

Whenever a Commemorative Flag is raised, it should be raised at these four locations:

- The Tacoma Municipal Building North (733 Market Street),
- The Tacoma Dome (2727 E D St),
- TPD Headquarters (3701 S Pine St), and
- TFD Headquarters (901 Fawcett Avenue).

Except as provided above, Commemorative Flags may be displayed and communicate messages, viewpoints and opinions only as authorized and approved by the City Council as an exercise of the City's official government speech. City Council shall only consider requests to display an additional Commemorative Flag if that request is made by a member of City Council. Council Member requests should explain how the flag represents the values of the City of Tacoma and articulate how raising the flag is government speech. The Council will not consider requests by an individual or other public or private group. Best practice is to work with community partners to secure flags to fly in association with the commemorative event being celebrated. Flags should be returned to the community partner or securely stored for use in future years.

Federal and state laws provide protocols for flying the United States, Washington State, and Prisoner of War/Missing in Action (POW/MIA) flags at certain government buildings. Commemorative Flags must be the same size or smaller than the United States or Washington State flags being flown. The City Manager may also direct the display of the official flag of the City of Tacoma to create civic pride, denote a sense of place, and reflect the vibrancy of our residents and our community, provided the City Council has not authorized another Commemorative Flag for the same location and period of time.

Occurrences that may limit flying the Commemorative Flag as directed:

- The U.S. Flag Code requires flying the POW/MIA flag on certain days which would supersede local rules or council direction<sup>1</sup>.
- If the U.S. flag is required to be flown at half-staff, the commemorative flag would also be required to fly at half-staff. If the location does not have the infrastructure to fly the Commemorative Flag at half-staff, the Commemorative Flag should be removed during that time period.
- If the City is unable to secure donated flags or funding for additional flags.

The Tacoma Dome may also reserve the right to fly flags at its venue when the flag is associated with a specific event held there. Commemorative Flag policies for Tacoma Public Utilities, the Tacoma Public Library, and the Tacoma Municipal Court are to be determined by the Public Utilities Board, Library Board, and Tacoma Municipal Court, respectively.

DESIRED RESOLUTION DATE: March 18, 2025

#### **COMMUNITY ENGAGEMENT/ (CUSTOMER RESEARCH):**

Council Members have requested the City fly the current Commemorative Flags in collaboration with community-centered organizations to develop ways to acknowledge and celebrate our shared history. This has included the use of the three identified flags during annual recognitions. In June of

2023, the Mayor adopted a LGBTQIA2S+ PRIDE MONTH proclamation that included language on where Commemorative Flags would be raised at City facilities. Later, it was learned that there were challenges to achieving this goal, including the lack of flagpole infrastructure needed. This set up inaccurate expectations with the community and brought to light limitations to raising flags at all City facilities. The Queer City Collective (QCC) brought concerns to Tacoma City Council Members that identified the need a clear and consistent process.

#### **2025 STRATEGIC PRIORITIES:**

#### **Equity and Accessibility:**

The City of Tacoma Proclamations play a critical role in the City of Tacoma in highlighting the positive impact different demographics and affinity groups have had in the City of Tacoma. There is no process set by Council to clarify how to honor and celebrate these communities and issues through display of Commemorative Flags.

#### **Civic Engagement:** *Equity Index Score*: Moderate Opportunity

Elected officials, boards, commissions, and volunteer leadership will reflect the diversity of the Tacoma community.

Increase the percentage of residents who believe they are able to have a positive impact on the community and express trust in the public institutions in Tacoma.

Representation at public meetings will reflect the diversity of the Tacoma community

Explain how your legislation will affect the selected indicator(s)?

Tacoma is an inclusive, welcoming City, that stives to build belief and trust with all people in our community. A clear, transparent process for how Commemorative Flags are selected and when and where they will be raised is needed to build that trust.

#### **EVALUATIONS AND FOLLOW UP:**

The City Manager should work with the Mayor and Council to identify community partners which have historically collaborated on providing Commemorative Flags to coordinate on acquiring the required Commemorative Flags for this directive. The City Manager should inform the City Council of any barriers to acquiring the necessary flags with ample time for the City Council to consider allocating funds through Council Contingency or other methods.

#### **SPONSOR RECOMMENDATION:**

Sponsors recommend Council adopt this resolution to provide direction to the City manager on where and when to raise Commemorative Flags at City of Tacoma facilities.

#### FISCAL IMPACT:

This policy would require staff support and coordination from various City staff who are responsible for flags. Impacts associated with these three commemorative flags will be incorporated into ongoing workload within staff's standard working hours. Future policy direction to add additional commemorative flags could have additional fiscal impacts. This resolution does not provide funding to enhance any infrastructure needed to fly flags, nor does it provide funding to purchase Commemorative Flags.
