## **Briefing Items**

1. <u>23-0835</u> Affordable Housing Action Strategy Update

At approximately 12:00 p.m, Jacques Colon, Chief Strategy Officer, Office of Strategy, introduced Ted Richardson, Strategic Initiatives Program Coordinator, Office of Strategy, and presented a brief introduction to the Affordable Housing Action Strategy, including the four objectives to create more homes for more people, keep housing affordable and in good repair, help people stay in their homes and communities, and reduce barriers for people who often encounter them. Richardson presented the actions, noting inclusionary zoning and diverse housing types; middle housing zoning framework; Accessory Dwelling Units (ADU) accelerator and diverse housing types; multi-family tax exemption (MFTE), noting updates and objectives; surplus land policy updates; offsite infrastructure support, noting the Housing Equity Infrastructure Program and Connecting Housing to Infrastructure Program; increased participation and resources for new home buyers, noting the Homeownership Services Program; affordable Housing Trust Fund; and streamlining permit review process. Together, they continued with outlining objectives and actions, including keeping housing affordable and in good repair, noting owner occupied housing repair, and improving tracking of existing affordable housing properties; helping people stay in their homes and in their communities, noting tenant protections, resources for housing and rental assistance, and low-income homeowner relief; and reducing barriers for those who often experience them. They concluded by

reviewing homeless emergency sheltering system; decarbonization strategy; and Anti-Displacement Strategy, noting programs and assistance in development; and next steps.

Discussion ensued regarding gratitude for staff's work; fee in-lieu program and affordable housing requirements; mid-scale residential target areas, noting the MFTE program and keeping housing affordable; inclusionary zoning and the Housing Trust Fund; permit review process; municipal tools and options; increasing funding, program demand and capacity; Landlord Tenant Program and trainings; permanent affordable housing, noting community land trust and developer incentives; mortgage, rental, and housing assistance programs; resources page on City website; permit review timeline; low-income housing relief and market-rate housing; Rental Housing Code informational pamphlets and mailings; evictions and displacement tracking, noting movement of Tacoma Public Utilities srevice areas as data; ADU construction cost and financing; and availability of the Housing Trust Fund and the fee-in lieu funds.
