Charter Review Committee Overview of Work and Recommendations for Consideration

At approximately 12:01 p.m., Stephen Wamback, Chair of the Charter Review Committee (CRC), introduced the members of the CRC including, Latasha Palmer, Rebecca Stith, Melissa Malott, Andrea Reay, Nicholas Carr, Katie Baird, Patrick Fischer, and Bryan Flint. He then provided a background on their process, including subcommittees, noting public utilities, power of the people, administration, miscellaneous, police accountability, form of government, and public outreach; proposed amendments and recommendations; and the CRC meeting schedule.

Discussion ensued regarding how Council Members can be helpful to the CRC, noting high level questions versus detailed; recommendations, including land acknowledgement, form of government, and term limits; full-time City Council, noting additional staff; salary commission conflict; citizen and freeholder language; eligibility for employment, noting resident requirement; official newspaper; Landmarks Preservation Committee; Tacoma Public Utilities (TPU), noting a proposed new member on the Public Utility Board from the TPU service area and purpose of inquiry; employee anti-discrimination language; City Attorney position; Planning Commission, noting membership increase; disposition of City-Owned property; police accountability; initiative and referendum process; campaign finance policy;

Charter review frequency; Neighborhood Councils; proposed Climate Commission; appreciation for the time and volunteering efforts; ballot requirements; top priorities and volume of recommendations, noting equity, justice issues, and public comments; ballot, election, and CRC timeline options; committees, boards, and commissions requirements; legal review of recommendations; previous CRC's ballot process; process of prioritization, noting policy changes via resolutions and ordinances versus going to the ballot; community engagement; packaging recommendations together; Library Board of Trustees membership makeup; cost of recommendations; community education and transparency; and voter fatigue.
