Chair Echtle passed around the Art at Work Month Proclamation.

6. Staff Check-In **5:05 pm (01:30)**

The first two parts of Elizabeth Conner's Pacific Avenue Streetscape public art project have been installed. A celebration event was held on December 7. Elizabeth's final pieces will be installed in January.

The base for the Sun King public art piece is out to bid with a tentative installation in early spring.

Arts Projects funding applications were due on December 6. The Commission received 24 applications to date.

Thank you letters from funding recipients were shared with Commissioners.

The dedication of the Stadium District mural will be held on December 14, 12 pm.

A volunteer juror is sought from the Commission for an upcoming Rainier League of Arts exhibit.

7. Presentations

A. Proposed Site Alterations at Pantages **5:09 pm (05:39)**

David Fischer presented on the \$45 million capital campaign that the Broadway Center for the Performing Arts (BCPA) has underway to improve the current facilities of the Pantages, Rialto, and Theater on the Square as well as develop new facilities in the Theater on the Square Park and redevelop The Winthrop building. Commissioners asked clarifying questions.

In 1993, under a commission from the Greater Tacoma Community Foundation, Doug Granum created a series of 14 rock sculptures and 20 mask pieces that were sited around the Theater District. In 1996, the collection was gifted to the City of Tacoma.

There will be a meeting on December 19, 11 am in Studio 2 at the Broadway Center which will include a discussion of the public art around the BCPA. Mr. Fischer showed visual diagrams of the proposed redevelopment of the sidewalk in front of the Pantages, Theater on the Square, and Theater on the Square Park. The proposed redevelopment of theaters would include moving the Doug Granum rock sculptures currently sited in front of the Pantages and in Theater on the Square Park to allow for a better



flow and safety of pedestrian traffic. The Commission would need to approve any potential resiting of the pieces. Commissioners asked clarifying questions.

8. Action Items

A. Siting of Art Benches in Ruston-Pt. Defiance Business District 5:52 pm (48:57)

Juel Lugo and Jennifer Weddermann presented on the bench/bike rack to be sited on the northwest corner of N. 51st and Pearl Street. They showed examples of Ms. Weddermann's past work as well as drawings of the proposed bench. The bench will be fabricated from ½" mild steel plate with rounded edges; the bench will be painted and will be ADA accessible. Commissioners asked clarifying questions.

The bench was funded through the 2013 Arts Projects funding program. The Commission reviewed the bench because it is an art piece and/or has artistic elements and it is proposed to be sited in public right of way.
