Joint City Council / Public Utility Board Briefing Item

1. 23-0379 Annual Climate Action Progress Report Update

At approximately 12:06 p.m., Jim Parvey, Environmental Policy and Sustainability Division Manager, Environmental Services (ES), provided opening remarks on the progress report for the City's Climate Action Plan (CAP); introduced Kristi Lynett, Sustainability Officer, Office of Environmental Policy and Sustainability, and LaTasha Wortham, Senior Government Affairs Advisor, Tacoma Public Utilities (TPU); and presented background on the CAP, noting greenhouse gas emissions, and the City's net-zero goal by 2050. Lynett reviewed the 2030 climate milestones and provided an overview of the CAP, noting that it was adopted in November 2021 and includes actions and target indicators. Together, Lynett and Wortham presented the 2030 indicators and related jump start actions related to the CAP themes of togetherness, living, breathing, resource use, opportunities, and preparedness. They concluded by reviewing ways the City is leading by example, noting reducing fleet, building, and infrastructure emissions, and engaging employees in sustainability; opportunities for local solutions, noting state and federal leadership and grants; next steps, noting the high tide event in December 2022; and invited everyone to the South Sound Sustainability Expo on Saturday, April 22, 2023.

Discussion ensued regarding heat islands, noting interventions and correlation with low-opportunity areas on the City's Equity Index; retrofitting buildings, noting targets, costs, and funding sources; electric bicycle incentives; greenhouse gas emissions from power utilities; food waste regulations and programming; electric vehicles, noting car share programs, charging stations, and incentives; home energy conversions and support; carbon credits; bicycle infrastructure; tree planting; barriers to construction firms; and data, noting sources used, and frequency of new studies.

City Council / Public Utility Board Joint Executive Session - Potential Litigation

City Council Briefing Item

2. <u>23-0380</u> Emergency Medical Services Levy Lid Lift

At approximately 3:23 p.m., Tory Green, Chief, Tacoma Fire Department (TFD), provided opening remarks and introduced Teresa Green, Business Services Senior Manager, TFD. Green presented the Emergency

Medical Services (EMS) levy lid lift, including background, noting erosion of existing levy rates; the upcoming timeline for proposition to be on the Tuesday, August 1, 2023, Primary Election ballot; the proposed ballot title, noting the purpose and how the percentage and term were selected; a comparison of levy rates per \$1,000 of assessed value under the proposed levy lid lift and the existing rate; revenue available through existing and proposed EMS levy collection rates; outreach; and recommendations.

Discussion ensued regarding outreach, noting methods and political campaign restrictions; tax exemptions, noting criteria and how people know they qualify; impacts on possible future levies; history of the previous EMS levy, noting increased call volumes over time; and tax-funded services.
