

**Human Rights Commission**

**January 16, 2014**

**Chair Schuneman called the meeting to order at 7:50 p.m.**

**Approval of Minutes**

A motion was made, seconded, and carried to accept the HRC meeting minutes for December 19, 2013.

**Agenda Approval**

Chair Schuneman called for a motion to amend and approve the HRC Business Meeting Agenda to include two items in "Other Business", and move the balance to the February meeting. A motion to approve the amended January 16, 2014, Human Rights Commission Business Meeting Agenda was made, and seconded, followed by a discussion of the topics moving to February. The motion carried.

**Other Business**

Chair Schuneman explained that we did have a motion to make Restorative Justice an item for the February Study Session. Additionally, the Commission needs to talk about 1.29 impacts and the direction we want to go. One issue is Reasonable Cause, and the second is the recommendation from the Disability Commission to reduce the number of people necessary to meet regulations. We are also going to discuss what we have learned about petitions for reconsideration, and drafting procedures. A motion was made and seconded to move Restorative Justice to the March Study Session Agenda and cover the 1.29 issues with the February agenda. The motion carried.

Commissioner Smiraldo spoke of his Spark Grant for an audio anthology that is titled "The Spirit of Place", and possible Commissioner Participation.

### **Director's Report**

Director Hayward mentioned that the HRC will have two new members after their Council Appointment. There were nine applications for three seats which speaks to the desire in the community to join in with the direction the Commission is taking.

February 27, there is a potential joint meeting with the HRC and the Public Safety, Human Services and Education Committee to help create better alignment with Council Objectives.

The City Council has a work session on February 21, and will approve their 2014 strategic objectives, and if any changes, Ms. Hayward will discuss with the Commission. The City Council is considering a new strategic planning process for Tacoma. The last one was done in the early 2,000's or late '90's. It is likely to be a very community based process thinking about the long term vision for the city, and a lot of that will support planning for the 15-16 budget.

Director Hayward informed the Commissioners of the city's new P.A.S. S. initiative, and our new 311 phone number to the Customer Support Center and City QA. As of February 3<sup>rd</sup>, floors above three, in the Municipal Building will be closed to anyone without a security badge, and visitors will need to check in with Security to confirm appointments, and pick up a temporary badge.
