



## RESOLUTION NO. 41899

1 BY REQUEST OF DEPUTY MAYOR BUSHNELL, AND COUNCIL MEMBERS  
2 HINES, RUMBAUGH, AND WALKER

3 A RESOLUTION appointing individuals to committees that will prepare  
4 statements “For” and “Against” Proposition No. 1, Connect Tacoma:  
5 Safe Streets and Sidewalks, relating to utility and property tax increases,  
6 which will appear in the Voters’ Pamphlet for the August 4, 2026,  
7 Primary Election.

8 WHEREAS on April 14, 2026, the City Council adopted Resolution  
9 No. 41890, transmitting a proposition, relating to utility and property tax increases  
10 relating to Connect Tacoma: Safe Streets and Sidewalks street improvements,  
11 on the ballot for the August 4, 2026, Primary Election, and

12 WHEREAS on April 21, 2026, the City Council adopted Resolution  
13 No. 41894, which supersedes and replaces Resolution No. 41890, but does not  
14 affect the appointments to the “For” and “Against” committees, and

15 WHEREAS the Government Performance and Finance Committee  
16 reviewed letters of interest at their regularly scheduled meeting on Tuesday,  
17 April 21, 2026, and provided recommendations for the appointment of  
18 individuals to the “For” and “Against” committees for the proposition, and

19 WHEREAS, per the Revised Code of Washington 29A.32.280, for each  
20 measure from a unit of local government that is included in a local voters’  
21 pamphlet, the legislative authority of that jurisdiction shall, not later than the  
22 resolution deadline, formally appoint a committee to prepare arguments advocating  
23 voters’ approval of the measure, and shall formally appoint a committee to prepare  
24 arguments advocating voters’ rejection of the measure; Now, Therefore,
